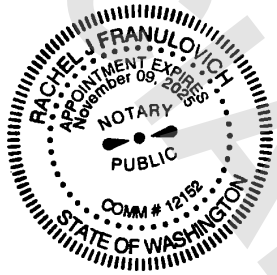

Legal Description

That portion of Lot 2, Block 12, of "MAP OF MOUNT VERNON, GATES 1<sup>st</sup> AND 2<sup>nd</sup> ADDITIONS TO MOUNT VERNON," as per plat recorded in Volume 2 of Plats, page 98, records of Skagit County, Washington, described as follows:

Beginning at the Southwesterly corner of said Lot; thence Northerly along the Westerly line of said Lot, 25 feet, more or less, to the Southwesterly corner of a tract of land conveyed to Felix Minor by document recorded September 10, 1959, under Auditor's File No. 585358, said Southwesterly corner being referred to as the Southwesterly corner of a red brick building and further being referred to as the Northwesterly corner of a concrete building in document recorded September 24, 1959, under Auditor's File No. 585836; thence Easterly along the South line of said Minor tract, 100 feet, more or less, to the Easterly line of said lot; thence Southerly along said Easterly line, 25 feet, more or less, to the Southeasterly corner of said lot; thence Westerly along the Southerly line of said lot, 100 feet, more or less, to the point of beginning; EXCEPT the Easterly 6 feet thereof for alley.
