MEMORANDUM OF EXCLUSIVE RIGHT TO SELL AGREEMENT

THIS MEMORANDUM OF EXCLUSIVE RIGHT TO SELL AGREEMENT (this "*Memorandum*") is dated as of March 7, 2022, by and between **HomeOptions, Inc. This Memorandum may be executed in two or more counterparts, each of which, when so executed and delivered, shall be an original, but all of such counterparts shall constitute one and the same instrument.

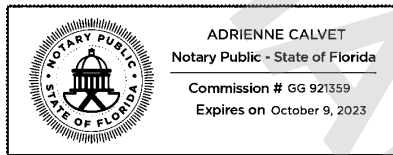

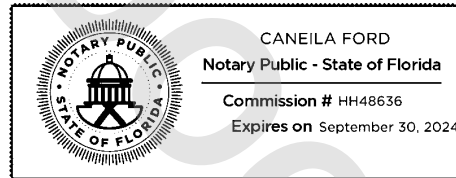
