THE GRANTOR, **Skagit Habitat for Humanity, Inc.**, a Washington nonprofit corporation, for and in consideration of **Three Hundred and Forty Nine Thousand Dollars and No Cents (\$349,000.00)** and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, hereby conveys and warrants to the GRANTEE, **Esmeralda Yzaguirre, an unmarried woman**, all of Grantor's interest in and to the following described real estate, situated in the County of Skagit, State of Washington, and legally described as follows, together with all after-acquired title of the Grantor therein:

Situate in the County of Skagit, State of Washington.

SUBJECT TO: Easements, restrictions and reservations of record.

No Discrimination. During such time as the property described herein is used for a purpose for which assistance under the Housing Opportunity Program Extension Act of 1996, P.L. 104-120, was provided or for another purpose involving the provision of similar services or benefits, then no person having an interest in this property shall refuse service for or accommodation or other benefits to any person with respect to the property on account of the person's race, color or national origin or otherwise engage in discrimination conduct of any kind on account of a person's race color or national origin with respect to the property.

First Right of Refusal. Should the Grantees or Survivor desire to sell or convey the Property, the Grantees or Survivor shall first offer the Property to Grantor, or its successor in interest, in the following manner:

The Grantees or Survivor shall serve notice in writing to **Skagit Habitat for Humanity, Inc., 1022 Riverside Dr., Mount Vernon, WA 98273**, or its successor in interest, by registered mail, return receipt requested. The notice shall indicate that the Grantees or Survivor have a bona fide offer for the sale of the Property, the Name and Address of the person desiring to purchase the Property, and the sales price and terms of payment for the sale. The notice shall also contain an offer to sell the Property to Grantor, or its successor in interest, upon the terms and conditions set

forth in the bona fide offer. A copy of any documents evidencing such bona fide offer shall be included in the notice.

For a period of thirty (30) days after the receipt of the notice, Grantor, or its successor in interest, shall have the right to purchase the Property in accordance with the terms of the bona fide offer. If Grantor, or its successor in interest, fails to exercise the right of first refusal set forth in this covenant, the Grantees or Survivor may sell or convey the Property to the party making the bona fide offer, but only at the price and upon the terms specified in the notice. Should the terms of sale change, Grantor shall be provided an additional offer notice containing the changed terms and/or conditions and shall have an additional thirty (30) day period in which to exercise its option to purchase the Property.

Restriction Upon Sale or Transfer of Home. Grantee(s) and Grantor agree that the provisions of this agreement are intended to preserve the affordability of the property for low income households and expand access to affordable homeownership opportunities for such households for 20 years in the future.

Grantee(s) may transfer the property only to Grantor or income qualified persons as defined below or otherwise only as explicitly permitted by the provisions in the First Promissory Note. All such transfers are to be completed only in strict compliance with this agreement. Any purported transfer that does not follow the procedures set forth, except in the case of a transfer to a Permitted Mortgagee in lieu of foreclosure, shall be null and void. A resale formula of 1.5% compounded annually is calculated based on the purchase price.

"Income Qualified Person(s)" shall mean a person or group of persons whose household income does not exceed eighty percent (80%) of the area median household income for Skagit County as calculated and adjusted for household size from time to time by the US Department of Housing and Urban Development (HUD) or any successor.


Home Assistance Funding and Intent to Sell of Transfer of Home. This property was made available to the low-income homebuyer with the aid of funds from the Community Development Block Grant Home Assistance funding. The conditions of this financial assistance of \$25,000 restricts resale of the property per section 1, and the Maker and Holder agree to bind themselves to said conditions so that this agreement serves the purpose of preserving the affordability of the property for low-income households. The funding provided to assist in the purchase of the home is preserved through the end of 10 years. Maker may transfer or sell the home per section 7, and the Holder will recapture the grant funding through the end of 10 years for future "Income Qualified Person(s)". The 10-year grant recapture period commences on the day the home is sold and transferred to the Maker. **This condition is material to Holder's agreement to lend.**

Nothing in this covenant shall prevent a sale or conveyance of the Property at any time provided the Grantees or Survivor receive the prior written approval of Grantor or its successor in interest.




