Road Maintenance Agreement Recording Cover Sheet

- (1) This is a private road agreement between Jon G. Bowman and Ann K. Bowman, owners of P73041, and Eugene P. and Donna D. Ferrario, owners of P19351, both parcels situate in Skagit County, Washington . This agreement insures equal use of the road by the Bowmans, Ferrarios, and their successors and assigns in perpetuity.
- (2) The Bowmans, their successors and assigns will not have the following described real estate quit claimed with a boundary line adustment or if necessary, will deed a reasonable easement for ingress, egress and utilities required for a structure over the same: that portion of 9th street starting at the centerline of Oliver Avenue extended southerly east to the centerline of Woodland Avenue extended southerly all within the plat of Lake View Addition of Fidalgo City, situate is Skagit County, Washington.
- (3) Hereinafter, Bowmans and Ferrarios, and their successors and assigns, will be referred to as party and collectively referred as parties. For purposes of the maintenance/repair portion of this agreement, anyone affiliated with either party shall be considered as that party's responsibility. (i.e. friends, contractors and etc.)
- (4) During periods when both parties are using said road, the parties hereto shall meet and establish necessary maintenance provisions. Such provisions shall include, but shall not be limited to:
- a) The appointment of a maintainer, which may or may not be one of the parties hereto or any third party, who will perform or cause to be performed at a reasonable and agreed upon rate the maintenance and /or resurfacing of said road: and
- b) A method of payment by which each party using said road shall pay its share of the cost incurred by said maintainer in maintaining or resurfacing said road.
- (5) For purposes of this agreement, maintenance is defined as the work normally necessary to preserve and keep said roadway, road structure, road facilities, ditches, and erosion maintenance on all surrounding properties as nearly as possible in their originally completed/existing condition or as therafter improved. Each party using said road shall repair, or cause to be repaired, at its sole cost and expense, that damage to said road occasioned by it which is in excess of that which it would cause through normal and prudent usage of said road. Should inordinate damage to said road occur which is not caused by an authorized user of said road, the parties hereto shall meet to agree upon the cost of repair/replacement, the party to undertake the repair/replacement, and the shares of repair/replacement cost to born by each user of said road.
- (6) Unless the parties hereto agree in writing to share the costs of improvements in advance of improvements being made, improvements shall be soley for the account of the approver.

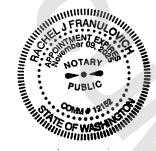
