ORDINANCE NO. 3857

AN ORDINANCE OF THE CITY OF MOUNT VERNON, WASHINGTON, VACATING CERTAIN PROPERTY AS PER PETITION FILED BY THE CITY OF MOUNT VERNON

WHEREAS, a petition has been filed pursuant to Chapter 35.79 RCW requesting portions of the alley located south of parcels P54139, P54141, P54142, and P54147; portions of the current 3rd Street Right of Way (ROW) along parcel P54147; portions of the south side of Kincaid St along parcels P54147 and P54142; and the platted 3rd Street ROW, be vacated, and

WHEREAS, the City Council of the City of Mount Vernon has on the 28th day of September, 2022, conducted a public hearing in compliance with the provisions of the RCW 35.79.030, after providing notice as required by RCW 35.79.020, and

WHEREAS, the City Council finds that the components of the below described property are no longer required for public use, has no public benefit, and there exists no public interest to be protected by retaining title to the described portions of said rights-of-way, and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MOUNT VERNON, WASHINGTON, DOES ORDAIN AS FOLLOWS:

SECTION ONE. The City Council hereby finds the right-of-way areas described and mapped within Exhibits A, B, and C of this Ordinance are surplus to the needs of the City and vacation will facilitate the development of a City owned public library and parking garage within the City, thereby providing a public benefit to the citizens of Mount Vernon, and that the extinguishment of the City's interest in these right-of-way areas will result in no adverse consequences to the public. An appraisal and compensation for the fair market value of the vacated areas has been deemed to not be required because the City already has all the property interest in these areas.

SECTION TWO. The relocated South 3rd Street subterranean right-of-way vacation areas described and mapped within **Exhibit A** to this Ordinance are hereby vacated.

SECTION THREE. The subterranean and above-grade right-of-way vacation area of the alley described and mapped within **Exhibit B** to this Ordinance are hereby vacated.

SECTION FOUR. The 3rd Street and alley full right-of-way vacation areas described and mapped within **Exhibit C** to this Ordinance are hereby vacated.

SECTION FIVE. Exhibits A, B, and C are incorporated herein and made part of this Ordinance as if set forth herein in full.

SECTION SIX. This ordinance shall be recorded in the office of the County Auditor.

SECTION SEVEN. Severability. Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this Ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.

SECTION EIGHT. City staff are hereby directed to complete preparation of the final ordinance, including correction of any typographical or editorial edits.

SECTION NINE. This ordinance shall be in full force and effect five days after its passage, approval and publication as provided by law.
