#### MEMORANDUM OF SITE LEASE AGREEMENT

This Memorandum of Site Lease Agreement ("Memorandum") is made this 4 day of OCTOBER, 202 , between BAHMAN SADIGHMEHR and DANA L. SADIGHMEHR, husband and wife, having an address of 8674 S March's Point Road, Anacortes, Washington 98221 ("Landlord"), and DISH Wireless L.L.C., a Colorado limited liability company having a place of business at 9601 S. Meridian Blvd., Englewood, Colorado 80112 ("Tenant," and together with Landlord, the "Parties," each a "Party").

- 1. Landlord and Tenant entered into a Site Lease Agreement (the "Agreement") on Commencement Date (as defined below). The Initial Term shall automatically renew for up to four (4) additional terms of sixty (60) months each. However, Tenant may, in Tenant's sole and absolute discretion, elect not to renew the lease at the end of the then-current term by giving Landlord written Notice at least ninety (90) days prior to the end of the then-current term. The Commencement Date is defined as the first (1st) day of the month following the commencement of Tenant's Installation.
- 2. Landlord is the owner of the that certain parcel of real property more particularly described in Exhibit A and commonly known as 8674 S March's PT RD, Anacortes, Washington 98221 (the "Property"). Pursuant to the Agreement, Landlord has leased to Tenant a portion of the Property consisting of an approximately 625 square feet parcel (the "Lease Area"), together with a non-exclusive right of way and easement for ingress and egress and for the installation of lines, wires, cables, circuits, conduits, poles, and associated equipment, improvements, fixtures and appurtenances for utility and similar services, over, under and along a twelve feet (12') wide area extending from the nearest public right of way to the Lease Area (together with any additional easements or rights of way described in the Agreement, the "Easements"). The Lease Area and Easements are initially described in Exhibit B, attached hereto and made a part hereof, and are collectively referred to as the "Premises".
- Landlord has granted a right of first refusal to Tenant as more particularly described in the Agreement.
- 4. The purpose of this Memorandum is to give record notice of the Agreement and the rights of the Parties created thereby, all of which are hereby confirmed. The terms, covenants and provisions of the Agreement are hereby incorporated by reference into this Memorandum and shall extend to and be binding upon the respective executors, administrators, heirs, successors and assigns of Landlord and Tenant.


