Beginning at the Northeast corner of said Lot 1;

Thence North 89°03'45" West on the North line of said Lot 1 a distance of 222.07 feet;

Thence South 6°53'46" East a distance of 118.34 feet;

Thence South 0°50'10" West a distance 611.20 feet;

Thence South 9°28'52" West a distance of 87.88 feet more or less to the South line of said Lot 1; Thence South 88°14'57" East on said South line a distance of 251.88 feet to the Southeast corner of said Lot 1:
