M., North of hill ground, EXCEPT ditch rights of way and building sites and that portion thereof conveyed to Skagit County for road purposes by Deed dated May 4, 1936 and recorded March 14, 1938, under Auditor's File No. 300030, and EXCEPT property described in Tax Parcel P103341 after the Boundary Line Adjustment dated June 25, 2018.

PARCEL B (approximately 16-acres)

The South half of the Northeast quarter (partial), the Northwest quarter of the Northeast quarter, less the Northern 4-acres (partial), all West of the Joe Leary Slough, Section 21, Township 35 North, Range 3 East, W. M., EXCEPT building site, dike and ditch rights of way and roads.

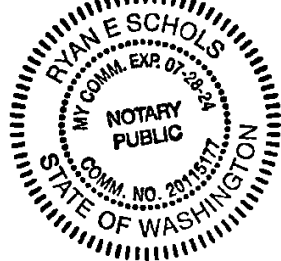

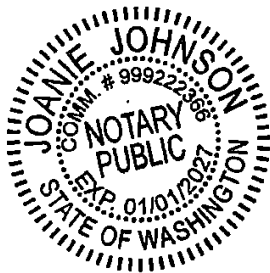
