

#### ASSIGNMENT AND ASSUMPTION OF DNR AQUATIC LANDS LEASE

This Assignment and Assumption of DNR Aquatic Lands Lease (this "Assignment"), effective as of the 22 day of February, 2023, is made by and between LOVRIC'S LANDING, LLC, a Washington limited liability company ("Assignor"), and GUEMES CHANNEL HOLDINGS, LLC, a Washington limited liability company ("Assignee").

#### **RECITALS**

- A. Assignor, as tenant, is the tenant under an aquatic land lease with the State of Washington, acting through the Department of Natural Resources ("DNR") dated January 1, 2019 and commonly known as Lease No. 22-A02606, as amended from time to time (the "DNR Lease") with respect to the premises and improvements located at 3022 Oakes Avenue in the City of Anacortes, Skagit County, Washington, as further described herein.
- B. Assignee, in connection with Assignee's purchase of the Property (as defined below) from Assignor, will acquire Assignor's interest in the DNR Lease, and is willing to assume all of the obligations of the Assignee under the DNR Lease accruing on and after the date of this Assignment; and Assignor wishes to transfer all of Assignor's interest under the DNR Lease to Assignee.

#### **AGREEMENT**

NOW, THEREFORE, in consideration of the covenants and agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. <u>Property</u>. The "<u>Property</u>" means the real property located in Skagit County, Washington which is legally described in <u>Exhibit A</u> attached to this Assignment, together with the building, structures and other improvements located thereon.
- 2. <u>Lease</u>. The "<u>DNR Lease</u>" means the lease defined in Recital A above and more particularly described in <u>Exhibit B</u> to this Assignment.
- 3. <u>Assignment.</u> Assignor hereby grants, transfers and assigns to Assignee the entire right, title and interest of Assignor in and to the DNR Lease.
- 4. <u>Assumption</u>. Assignee hereby assumes the covenants, agreements and obligations of Assignor as tenant under the DNR Lease which are applicable to the period and required to be performed from and after the date of this Assignment and Assignee further assumes all liability of Assignor from and after the date of this Assignment. No person or entity, other than Assignor, shall be deemed a beneficiary of the provisions of this <u>Section 4</u>.
- 5. <u>Successors and Assigns</u>. This Assignment shall be binding upon and inure to the benefit of Assignor and Assignee and their respective successors and assigns.
- 6. <u>Indemnification</u>. Assignor shall indemnify, defend, protect and hold harmless Assignee from and against all obligations of the Assignor under the DNR Lease (including, without limitation, attorney's fees, costs and expenses reasonably incurred in connection with any litigation, threatened litigation, or default) to the extent such obligations were applicable to the period prior to the date of this Assignment or required to be performed prior to the date of this

Assignment. Assignee shall indemnify, defend, protect and hold harmless Assignor from and against all obligations of the Assignee under the DNR Lease (including, without limitation, attorney's fees, costs and expenses reasonably incurred in connection with any litigation, threatened litigation, or default) to the extent that such obligations are applicable to the period following the date of this Assignment and required to be performed following the date of this Assignment. For further clarity, the obligations contained in amended Exhibit B, as set forth in that certain Amendment and Notice of and Consent to Assignment of Lease dated as of even date herewith, are not the responsibility of Assignee.

- 7. <u>Attorneys' Fees.</u> In the event either party brings an action or any other proceeding against the other party to enforce or interpret any of the terms, covenants or conditions hereof, the party substantially prevailing in any such action or proceeding shall be paid all costs and reasonable attorneys' fees by the other party in such amounts as shall be set by the court, at trial and on appeal.
- 8. <u>DNR</u>. This Assignment is conditioned upon and subject to the terms of that certain Amendment and Notice of and Consent to Assignment of Lease between Assignee, Assignor and DNR.
