This boundary adjustment is not for the purposes of creating an additional building lot.

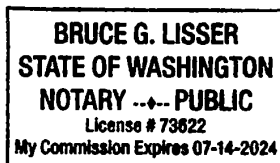

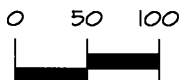

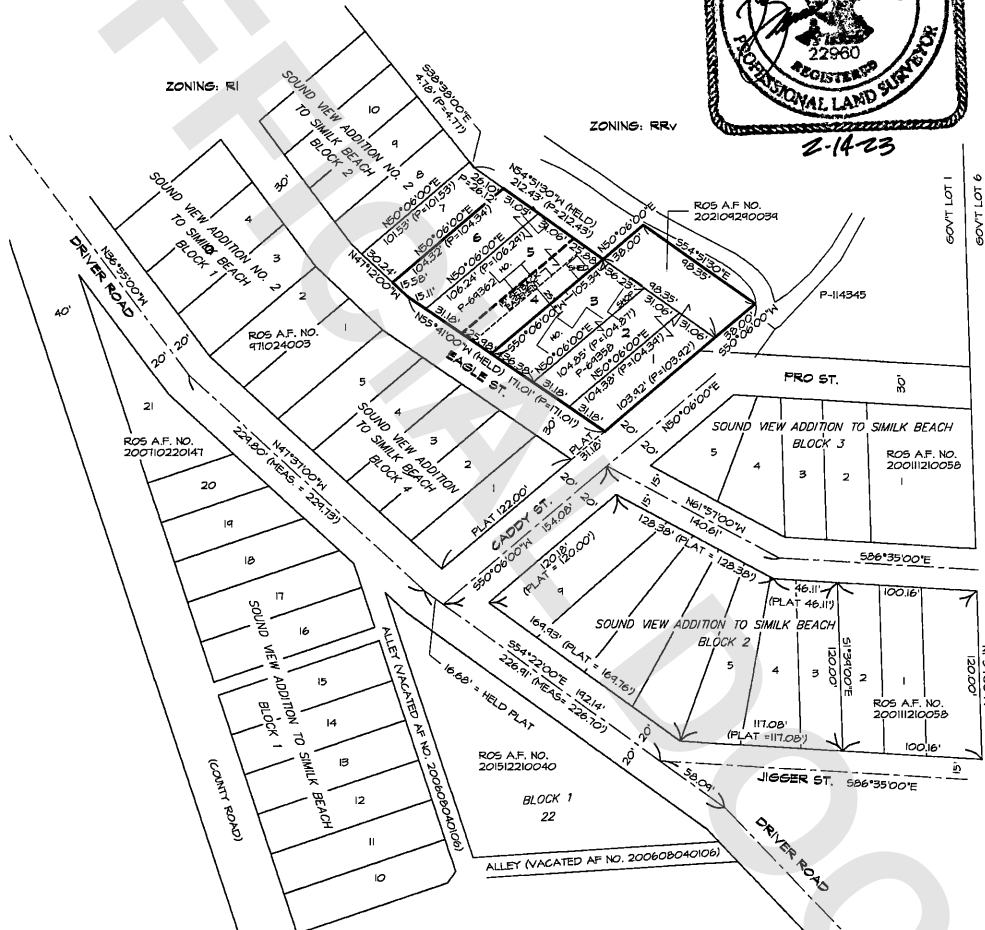
BOUNDARY LINE ADJUSTMENT EXHIBIT MAP
