Legal Description

Lots 1, 2, 3 and 4, Block 1, "ROBERTSON-EVERETT ADDITION", as per plat recorded in Volume 7 of Plats, page 32, records of Skagit County, Washington.

Lot 1, Block 2, "ROBERTSON-EVERETT ADDITION", as per plat recorded in Volume 7 of Plats, page 32, records of Skagit County, Washington.

That portion of the Southwest quarter of the Northeast quarter of Section 4, Township 34 North, Range 2 East, W.M. described as follows:

Beginning at a point on the East line of the County Road, 825 feet South and 20 feet East of the Northwest corner of said subdivision;
thence East 264 feet;
thence North 82.5 feet;
thence West 264 feet to the East line of the county road;
thence South along said county road 82.5 feet to the point of beginning.

Commencing at a point 825 feet South of the Northwest corner of the South half of the Northeast quarter of Section 4, Township 34 North, Range 2 East, W.M.;
thence running East 370 feet;
thence South 350 feet;
thence West 370 feet to the West line of the aforesaid Northeast quarter of Section 4;
thence North to the place of beginning;
EXCEPT that portion thereof lying within the Boundaries of the county road running along the West line thereof.

The South 350 feet of the North 1175 feet of that portion of the Southwest quarter of the Northeast quarter of Section 4, Township 34 North, Range 2 East, W.M., lying West of a line that is 387 feet East of the West line of said Southwest quarter of the Northeast quarter and lying East of a line that is 370 feet East of the West line of said Southwest quarter of the Northeast quarter.

That portion of the Southwest quarter of the Northeast quarter of Section 4, Township 34 North, Range 2 East, W.M., delineated as Tract "A" of "ROBERTSON-EVERETT ADDITION", as per plat recorded in Volume 7 of Plats, page 32, records of Skagit County, Washington. Together with that portion, if any, of the Southwest quarter of the Northeast quarter of Section 4, Township 34 North, Range 2 East, W.M., described as follows:
