The Southwest quarter of the Northwest Quarter of Section 34, Township 33 North, Range 4 Sast, W.M., SUBJECT TO: road right-of-way, and EXCEPTING therefrom the following tract:

The North 660 feet of the West 396 feet thereof.

TOGETHER WITH a non-exclusive easement for ingress, egress and underground utilities over, under and upon a strip of land in Skagit County, Washington described as follows:
