29 30 structures, junk, junked vehicles, and recreational vehicles; the excavation and remediation of any unlawful septic system as may appear on the site; as well as abatement and remediation of any other violations of law or ordinance as may appear upon entry of the Property, the reasonable costs of which may be pursued, recorded and foreclosed by Skagit County as a lien on the Property in accordance with applicable law.
