AGREEMENT AS TO STATUS OF COMMUNITY PROPERTY After Death of One of the Spouses

THIS AGREEMENT is made and entered into pursuant to RCW 26.16.120 by and between IAN E. ELLIS and MARCIA J. ELLIS, husband and wife, of Skagit County, Washington.

WITNESSETH:

In consideration of the love and affection that each of the parties has for the other, and in consideration of the mutual benefits to be derived by the parties, IT IS HEREBY AGREED:

- 1. Previously and After Acquired Property. All property of whatsoever nature or description, whether real, personal or mixed, and wheresoever situated, now owned or hereafter acquired by either or both of the parties shall be considered and is hereby declared as of the instant before the death of the first of the parties to die, and not before, to be community property; and each party's separate property, now owned or hereafter acquired, shall remain that party's separate property until the instant before that party's death at which time such separate property shall become community property.
- 2. Transfers at Death. Upon the death of either of the parties, title to all community property as herein defined shall immediately vest in fee simple in the survivor of the parties.
- **3. Termination of Agreement.** This agreement shall terminate and be of no further force and effect immediately upon the happening of the earlier of any of the following events:
 - (a) the filing, by either spouse, of a petition requesting dissolution of marriage;
