1 such care and treatment takes place outside a level one behavioral health
2 facility licensed by the Arizona Department of Health Services.

3 2. MEREDITH TRULOCK and KATHY WILSON are hereby appointed
4 as the co-conservators for DENIS TRULOCK with all of the powers set forth
5 in A.R.S. §§14-5424 and -5425, with the following restrictions: **no real**
6 **property shall be sold without court approval.**

7 3. DENIS TRULOCK's right to vote is suspended.

8 4. DENIS TRULOCK's right to obtain or retain a driver license is
9 suspended.
