

1. Delete sections 6, 6.1, and 6.2 of the original Lease dated August 29, 2022, and replaces with the following:
  6. During the term of this Lease, Lessor shall pay all real estate taxes, all property assessments, insurance, exterior window washing, landscape and irrigation water, and maintenance and repair as described below, together with exterior and interior bulbs and tubes, water, sewer, garbage service, natural gas, and electricity.
  - 6.1 Lessee shall pay for only janitorial service to include restroom supplies and interior window washing.
  - 6.2 Lessee shall reimburse Lessor for its prorata share of the following costs: water, sewer, garbage service, interior bulbs and tubes, natural gas, and electricity. Lessor shall submit a monthly voucher (with a copy of all bills and proof of payment for which reimbursement is requested) to be paid by Lessee for its prorata portion based on Lessee's leased space.

Lessee occupies 34,265 square feet or 65.3% percent of the total building and shall pay 65.3% percent of such charges.
6. All other terms, conditions, covenants, and amendments to this Lease, unless altered, modified, overridden, or changed herein, remain in full force and effect.
7. The effective date of this Amendment is March 1, 2023.
