PURCHASER'S ASSIGNMENT OF REAL ESTATE CONTRACT

Purchaser represents and warrants that (a) Purchaser has full authority to assign its interests under the Purchase Contract, (b) the Purchase Contract is in full force and effect, (c) Purchaser is not in default under the Purchase Contract, and (d) Purchaser has provided Assignee with a true, correct and complete copy of the Purchase Contract.
- 4. Assumption of Obligations. Assignee hereby assumes and agrees to perform all duties, obligations and liabilities of Purchaser under the Purchase Contract arising after the date hereof. Assignee shall indemnify and hold Purchaser harmless from any claims arising from Assignee's failure to perform such assumed duties and obligations.
- 6. Further Assurances. The parties shall take all actions and execute all documents reasonably necessary to effectuate the intent of this Assignment.
- 7. Governing Law. This Assignment is governed by the laws of Washington.
- 8. **Counterparts.** This Assignment may be executed in counterparts, each being deemed an original, and all of which together constitute one and the same instrument.
- 9. Captions. The captions in this Assignment are for convenience only and shall not be

considered in interpreting the Assignment.

10. Entire Agreement. This Assignment represents the entire agreement between the parties relating to the subject matter hereof.
