


A PORTION OF THE SE 1/4 OF THE SW 1/4 OF SEC. 26, TWP. 36 N., R. 2 E. W.M.,

**LEGAL DESCRIPTION**  
THE EAST 122 FEET OF THE FOLLOWING DESCRIBED TRACT:  
THE EAST 1/4 OF THE WEST 1/4 OF THE SW 1/4 OF SECTION 26, TOWNSHIP 36 NORTH, RANGE 2 EAST, W.M., EXCEPT THE SOUTH 20 FEET THEREOF CONVEYED TO SKAGIT COUNTY FOR THE PURPOSES OF THE SAMIISH SHORES PLAT, AND ALSO EXCEPT THAT PORTION, IF ANY, LING WITHIN "SAMIISH SHORES PLAT" AS PER THE PLAT RECORDED IN VOLUME 8 WASHINGTON, PAGE 7, RECORDS OF SKAGIT COUNTY;  
TOGETHER WITH ALL TORN AND OR ADJOINING SAID EAST 122 FEET, EXCEPT THAT PORTION THEREOF INCLUDED IN A TRACT, AS SHOWN ON THE SAMIISH SHORES PLAT, WHICH IS AVAILABLE FOR CULTIVATION OF OYSTERS, BY DEED ISSUED OCTOBER 15, 1901, UNDER APPLICATION NO. 3254 AND ALSO EXCEPT THAT PORTION THEREOF, AS SHOWN ON THE SAMIISH SHORES PLAT, AS PER THE PLAT RECORDED IN VOLUME 8 WASHINGTON, PAGE 7, RECORDS OF SKAGIT COUNTY;  
SITUATE IN THE COUNTY OF SKAGIT, STATE OF WASHINGTON.


