Modification: The said Deed of Trust is hereby modified as follows:

The beneficiaries, pursuant to the terms and conditions of the said Deed of Trust, have agreed to advance an additional sum of SEVENTY FIVE THOUSAND AND NO/100 (\$75,000.00) DOLLARS against the said Deed of Trust, thereby increasing the total sum secured by the said Deed of Trust to TWO HUNDRED SEVENTY FIVE THOUSAND AND NO/100 (\$275,000.00) DOLLARS, all of which is secured pursuant to the terms and conditions of the said Deed of Trust.

Continuing Validity: Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by the Lender to this Modification does not waive the Lender's right to require strict performance of the Deed of Trust as modified, nor

obligates Lender to make future modifications, except as otherwise agreed. Nothing in this Modification shall constitute a satisfaction of the Promissory Note secured by the Deed of Trust.

Grantor acknowledges having read all of the provisions of this Second Modification of Deed of Trust and Grantor agrees to its terms.

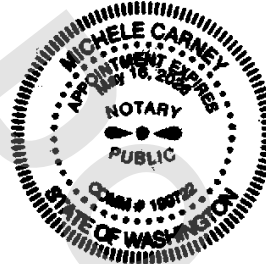


EXHIBIT 'A'

THAT PORTION OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 15, TOWNSHIP 35 NORTH, RANGE 8 EAST, W.M., DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF SAID NORTHWEST QUARTER OF THE SOUTHEAST QUARTER,

THENCE WEST 660 FEET;

THENCE NORTH 265 FEET TO THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION;

THENCE CONTINUE NORTH 155 FEET;

THENCE WEST 209 FEET;

THENCE SOUTH 155 FEET;

THENCE EAST 209 FEET TO THE TRUE POINT OF BEGINNING,

EXCEPT THAT PORTION LYING SOUTHERLY OF THE FOLLOWING DESCRIBED LINE:

THENCE NORTHWESTERLY IN A STRAIGHT LINE 91.54 FEET TO A POINT 80 FEET NORTH OF THE SOUTH LINE AND 90 FEET WEST OF THE EAST LINE OF THE ABOVE DESCRIPTION;
