Recitals

a. Hansens are the owners of the real property located at 1712 8th St., Anacortes, WA and described as follows:

Lots 14, 15 and 16, Block 158, "MAP OF THE CITY OF ANACORTES", as per the plat thereof recorded in Vol. 2 of Plats, pages 4-7, records of Skagit County, Wash.

b. The Schlobohm Trust is the owner of the real property located at 1716 8th St., Anacortes, WA and described as follows:

The East ½ of Lot 12, and all of Lot 13, Block 158, "MAP OF THE CITY OF ANACORTES", as per the plat thereof recorded in Vol. 2 of Plats, pages 4-7, records of Skagit County, Wash.

- c. The two parcels described above abut one another.
- d. On July 17th, 1996, an easement over the Hansen property was executed, benefitting the Schlobohm Trust property, and which was recorded under Skagit County Auditor's File No. 9607180098. The said easement did not set forth a specific location, apart from referencing a then-existing driveway located in the Northerly portion of the Hansen property.
- e. The parties have reached an agreement such that the location of the subject easement should be more specifically delineated, and execute this instrument to that end.

Agreement

Now, therefore, in consideration of the easement, and for no monetary consideration, IT IS HEREBY AGREED AS FOLLOWS:

- 1. The parties hereby reaffirm and agree that the said easement is and continues to be a valid appurtenance benefitting the Schlobohm Trust property.
- 2. The parties further agree that the location of the subject easement shall be as follows:

That portion of Lot 14, Block 158, "MAP OF THE CITY OF ANACORTES", as per the plat thereof recorded in Vol. 2 of Plats, pages 4-7, records of Skagit County, Wash. described as follows:

Commencing at the Northwest corner of the said Lot 14;

thence Southerly along the Westerly boundary thereof, a distance of 39.00 feet;

thence Easterly parallel with the Northerly boundary of the said Lot 14, a distance of 5.00 feet;

thence Northerly parallel with the Westerly boundary of the said Lot, a distance of 39.00 feet;

thence Westerly along the Northerly boundary thereof, a distance of 5.00 feet to the point of beginning.

- 3. Hansens specifically grant and convey to the Schlobohm Trust, and its heirs, successors and assigns, a perpetual non-exclusive easement for driveway and parking purposes benefitting the Schlobohm Trust property over and across the area set forth in paragraph (2) above; and, further, the Schlobohm Trust does hereby convey and quitclaim to Hansen, and Hansen's heirs, successors and assigns, all of its interest in any portion of the Hansen property not included in or encompassed by the said area.
- 4. A diagram showing the approximate location of the revised easement area is attached hereto as Exhibit A.


