

Williams, husband and wife, having appeared through their attorneys of record, Craig Cammock and John Burke of Skagit Law Group, PLLC, and the court having heard this matter by trial to the bench on December 14, 2009, and the court being fully advised in the premises,

The court finds that based on the Plat of Lake Cavanaugh Subdivision No. 3, the Disputed Property, being that land as depicted on the Skagit county plat map located between lots 176 and 177 of Lake Cavanaugh Subdivision #3 and Lake Creek, being bordered on the northwest by Plaintiff's Lot 2 and on the southeast by the extension of the southerly lot line of Lot 176 extended to the waters of Lake Creek was intended by the original platters to be completely included within Lots 176 and 177 and is now legally owned by Defendants Williams.

The court further finds that Plaintiff failed to show by a preponderance of the evidence satisfaction of the elements of adverse possession.

Based upon the above findings,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the claims filed by Plaintiff, THE HEYE SPECIAL NEEDS TRUST FBO DYLAN LEE SANDERS-GRIFFITH DATED JUNE 30th, 2001, against Defendants RICHARD AND COLLEEN WILLIAMS are hereby dismissed with prejudice; and

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Defendants Richard "Rick" and Colleen Williams, husband and wife, possess superior title in and to the Disputed Property as against the adverse claims of the Plaintiff, and any and all person claiming by, through, or under Plaintiff as to the Disputed Property; and

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that title to the Disputed Property is hereby quieted in Defendants Williams as against the claims of all persons or parties known or unknown claiming any right, title, estate, lien or interest in the Disputed Property; and
