I, Don McDermott, Sheriff of Skagit County, State of Washington, do hereby certify that a WRIT OF EXECUTION did issue out of the Superior Court of SKAGIT County, Washington, on May 1, 2023, upon a judgment rendered in Superior Court of SKAGIT County, Washington on April 12, 2023, in favor of LAKE TYEE, a Washington nonprofit corporation, for the sum of Sixteen Thousand, Three Hundred Sixty-Seven Dollars and Twenty-Five Cents (\$16,367.25).
