Legal Description

That portion of the Northeast quarter of the Northwest 1/4 of the Southeast quarter of Section 18, Township 35 North, Range 5 East, W.M., described as follows:

Commencing at the northeast corner of said subdivision;

Thence South 1°31'45" east along the East line thereof 144.50 feet;

Thence South 89°47'00" West 21.41 feet to the Westerly margin of the Fruitdale County Road,

Said point being the True Point of Beginning;

Thence continue South 89°47'00" West 120 feet;

Thence North 1°34'30" West parallel with said Westerly margin of the Fruitdale County Road 76 feet;

Thence North 89°47'00" East 120 feet more or less, to the Westerly margin of said Fruitdale County Road;
