This Termination of Easement Agreement (the "Termination") is entered into by and between EXYC Property Management LLC, a Washington limited liability company ("Grantor") and Community Action of Skagit County, a Washington non-profit corporation, ("Grantee") on December 18, 2024.

#### RECITALS

- A. Grantor owns the property described as follows: LOT 2, MOUNT VERNON SHORT PLAT NO. LU07-030, APPROVED OCTOBER 8, 2012 AND RECORDED OCTOBER 11, 2012 UNDER AUDITORS FILE NO. 201210110104, BEING A PORTION OF LOT B, PLAT OF KULSHAN VIEW, DIVISION NO 1, AS PER PLAT RECORDED IN VOLUME 13 OF PLATS, PAGE 8, RECORDS OF SKAGIT COUNTY, WASHINGTON, SITUATE IN SKAGIT COUNTY, WASHINGTON (the "Grantor Property").
- B. Grantee owns the property described as follows: LOT A, "PLAT OF CAVIEZEL-RAGSDALE DIVISION NO. 1", AS PER PLAT RECORDED IN VOLUME 13 OF PLATS, PAGE 41, RECORDS OF SKAGIT COUNTY, WASHINGTON, SITUATE IN SKAGIT COUNTY, WASHINGTON (the "Grantee Property").
- C. The Grantor Property and the Grantee Property are adjacent neighbors. Pursuant to a previously recorded document (Skagit County Recording Number 8004160056), the Grantor enjoys an easement over the Grantee Property for the purpose of overflow parking (the "Easement").
- D. The parties now desire to execute and record this Termination in order to confirm the termination of the Easement and its removal from the real property records of Skagit County, Washington.

#### AGREEMENT

NOW, WHEREFORE, in consideration of the mutual promises granted herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby affirmed,

1. The Easement is hereby terminated, and neither the Grantee Property nor the Grantor Property shall hereafter be burdened by any easement or license, whether express, implied, written, oral, or by prescription, benefiting the other property for the purpose of overflow parking.
2. This Termination shall become final and effective on the date recorded.
3. This Termination may be signed in any number of counterparts, each of which shall be an original and all of which shall constitute the same instrument.
