This matter came on for consideration without oral argument before the undersigned  
judicial officer of Skagit County Superior Court on the Plaintiff's Motion for Entry of Judgment.

1 Plaintiff appeared through attorney of record, Chawisa Laicharoenwat. The Court, having  
2 reviewed the file and records herein, having read and considered the Declaration of Counsel in  
3 support of the motion, and deeming itself fully advised, now makes the following findings and  
4 conclusions:

5 **FINDINGS**

- 6 1. Defendants are in default.
- 7 2. There was an express covenant given for the Defendants' payment of assessments to the  
8 Plaintiff, secured by a homeowners' association lien on the real property described below  
9 (Subject Real Property).
- 10 3. The Defendants have breached this covenant.
- 11 4. The Subject Real Property is described as follows:  
12 LOT 279, "PLAT OF SKAGIT HIGHLANDS DIVISION V (PHASE 1)," AS PER PLAT  
13 RECORDED ON DECEMBER 21, 2006, UNDER AUDITOR'S FILE NO. 200612210067,  
14 RECORDS OF SKAGIT COUNTY, WASHINGTON. SITUATE IN THE CITY OF MOUNT  
15 VERNON, COUNTY OF SKAGIT, STATE OF WASHINGTON.
- 16 5. The Subject Real Property is commonly known as: 5233 Razor Peak Drive, Mount Vernon,  
17 WA 98273.
- 18 6. Plaintiff's monetary claim against the Defendants includes a claim for delinquent  
19 assessments, interest, late charges, and costs of collection, including attorney's fees.
- 20 7. The Plaintiff's lien against the Subject Real Property secures payment of delinquent  
21 assessments, interest, late charges, and costs of collection, including attorney's fees.
- 22 8. The Plaintiff is not prosecuting any other action for the same monies owed or matter, and  
is not seeking to obtain execution of any judgment in any other action.

- 1 9. Defendants are not in military service.
- 2 10. Defendants are neither infants nor incompetent persons.
- 3 11. Proof of Service as required by CR 55(b)(4) was filed with the Court on or about January
- 4 24, 2025.
- 5 12. The amount of damages is in an amount certain as of January 24, 2025, including all
- 6 unpaid assessments and costs of collection.

7 **CONCLUSIONS**

- 8 1. The Court has jurisdiction over the parties and subject matter of this lawsuit.
- 9 2. The Defendants are in breach of the Covenant to Pay Association assessments, and are in
- 10 default.
- 11 3. The Plaintiff is entitled to judgment against the Defendants as a result of the Defendants
- 12 breach of Declaration obligations, including all assessments due but not paid, and all costs of
- 13 collection, including attorney's fees.
- 14 4. The lien amount as of January 24, 2025 is \$4,464.46. The lien amount includes unpaid
- 15 assessments, interest, late charges, and costs of collection, including attorney's fees.
- 16 5. The Association's lien is valid, has not been waived by the Plaintiff, the priority date is
- 17 August 17, 2005, the lien is of a continuing nature and may increase until satisfied, and the lien
- 18 is superior to all right, title, and interest of the Owners.
- 19 6. The debt amount as of January 24, 2025 is \$4,464.46. The lien amount includes unpaid
- 20 assessments, interest, late charges, and costs of collection, including attorney's fees.

1. That the Motion for Entry of Judgment be granted;
2. That judgment be entered against the defendants, and in favor of the plaintiff, in the amount of **\$4,464.46** as of about January 1, 1980.
3. That the judgment shall bear interest at 12% per annum from the date on which judgment is entered.
4. That the Plaintiff's lien has not been waived and remains as an encumbrance against the Subject Real Property until satisfied.
5. That the Plaintiff may record the judgment with the recording office of Skagit County and the recording office of any other County where the Defendants may have property interests.
