THIRD AMENDMENT TO LEASE

This **THIRD AMENDMENT TO LEASE** (the "Third Amendment") is made and entered into this **24** day of **February**, 2025, by and between the **PORT OF SKAGIT COUNTY**, a Washington municipal corporation (hereinafter referred to as "Lessor"), and **FORTRESS WEST**, **LLC**, a Washington limited liability company, (hereinafter referred to as "Lessee").

WHEREAS, the Lessor and Lessee entered into that Land Lease Agreement dated September 20, 2019 and amended or modified as follows by First Amendment to Land Lease Agreement dated September 25, 2020 (the "Lease"), and Second Amendment to Land Lease Agreement dated January 24, 2025, wherein the Lessor leased property to Lessee defined as the "Premises" in the Lease; and

WHEREAS, a completed survey of Lessee's leased premises reflects new legal description; and

WHEREAS, Lessor and Lessee desire to amend the Lease on the terms and conditions set forth in this Third Amendment.

NOW, THEREFORE, the Lease is hereby amended as follows:

- 1. A new Paragraph 1.1 Access Rights is added to the Lease reading as follows:
 - 1.1 Access Rights. During the term of this Lease, Lessor grants Lessee the non-exclusive rights of ingress and egress to the Primary Lease Area over and across the private road owned by the Lessor commonly referred to as the Bayview Road Extension.
- 2. **CLAIM WAIVER**: In partial consideration for the Lessor consenting to this Third Amendment, the Lessee does hereby forever release, indemnify, and hold harmless the Lessor and its commissioners, employees, and agents from any and all Claims arising from, or connected with, the Lease or the Premises through the date of this Third Amendment. For purposes of this paragraph, the term "Claims" means any and all claims, demands, lawsuits, judgments, demands, fines or penalties, whether known or unknown and whether liquidated or unliquidated on the date of this Third Amendment.
- 3. **LEASE TERMS**: All other terms and conditions of the Lease shall remain the same and in full force and effect.
- 4. **VALIDATION:** IN WITNESS WHEREOF, Lessor has caused this instrument to be signed by its Executive Director by authority of the Commission of the Port of Skagit County, and this instrument has been signed and executed by Lessee, the day and year first above written
