MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE (the "Memorandum") is made as of the 14th day of August, 2025, by and between MLC PROPERTIES, LP, a Washington limited partnership (referred to herein as "MLC") and S & B FARMS, INC., a Washington corporation (hereinafter referred to as "S & B").

This Memorandum of Lease includes a right of first refusal to purchase the Property, as that term is defined below.

AGREEMENT

- 1. <u>Memorandum.</u> MLC and S & B have entered into that certain Lease Agreement dated as of January 1, 2025 (the "Lease") pursuant to which MLC is leasing to S & B certain real property legally described on <u>Exhibit A</u> attached hereto (the "Property"). The parties hereto are entering into this Memorandum for the purpose of incorporating the terms and conditions of the Lease and for the purpose of recording an agreement to give notice of the terms of this Memorandum and the Lease.
- 2. <u>Term.</u> The term of the Lease is effective for a period of six (6) years commencing on January 1, 2025 and expiring December 31, 2030, unless extended by mutual agreement of MLC and S & B.
- 3. <u>Notice</u>. All notices, requests, demands and other communications required or permitted hereunder shall be in writing and shall be given by: (a) hand delivery; (b) first-class

mail postage prepaid and registered or certified mail, or (c) overnight receipted courier service, which notice is addressed to the party at the address set forth below, or such other address as may hereafter be designated in writing by the party. Notices given in accordance with this Section shall be effective upon receipt or when receipt is refused.
