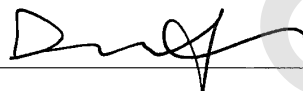
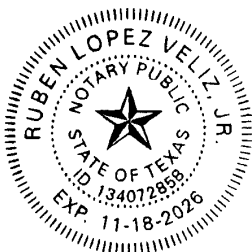

X. NOTICE TO OCCUPANTS OR TENANTS
