

Exhibit 'A'

That portion of the West 1/2 of the Southeast 1/4 of Section 9, Township 35 North, Range 5 East, W.M., described as follows:

Beginning at the Southeast corner of said subdivision; thence North 0 degrees 15'35" East along the East line of said subdivision, a distance of 1140.20 feet; thence South 89 degrees 13'20" West parallel with the South line of said subdivision, a distance of 562.00 feet to the true point of beginning of this description; thence continuing South 89 degrees 13'20" West, a distance of 7.14 feet; thence North 10 degrees 45'14" West, a distance of 420.85 feet; thence South 76 degrees 53'35" West, a distance of 323.14 feet; thence South 45 degrees 36'15" East, a distance of 200.00 feet; thence on a curve to the right, having a radius of 150.00 feet, an arc distance of 111.11 feet; thence South 3 degrees 09'50" East; a distance of 77.93 feet; thence on a curve to the left, having a radius of 100.00 feet, an arc distance of 119.34 feet; thence South 71 degrees 32'20" East, a distance of 96.11 feet; thence on a curve to the right having a radius of 100.00 feet, an arc distance of 45.17 feet to a point designated herein as "Point A", at which point the tangent to said curve bears South 45 degrees 39'30" East; thence North 44 degrees 20'30" East, a distance of 10.00 feet; thence North 5 degrees 56'20" West, a distance of 98.34 feet to the true point of beginning. (Said premises being known as Tract "A" of Skagit County Short Plat No. 7-73, approved March 27, 1971.)

TOGETHER WITH a 60 foot wide non-exclusive easement for ingress and egress and utility purposes, over, across and through said West 1/2 of the Southeast 1/4 of said Section 9, and that portion of the Northwest 1/4 of the Northeast 1/4 of Section 16 of said Township, lying North of State Route No. 20, as delineated on Skagit County Short Plat No. 7-73.
