## WASHINGTON STATE HOMESTEAD DECLARATION

- I, Alexandra K. Lemelson, being first duly sworn, hereby declare and state as follows:
- 1. I am the owner and occupant of the real property located at 31004 Prevedell Road, Sedro-Woolley, WA 98284, situated in Skagit County, Washington, State of Washington. This property constitutes my principal residence.
- 2. I am filing this Homestead Declaration pursuant to RCW 6.13 to claim the protections provided under Washington law against involuntary sale or seizure of my residence.
- 3. I am a disabled individual. Due to my condition, I experience ongoing financial and personal hardship that make maintaining my housing security essential. This homestead declaration is necessary to preserve my legal protections and stability.
- 4. A minor child with a disability also resides on the property. The child's well-being and stability depend on maintaining this home environment, which provides continuity of care, accessibility, and safety essential to their needs.
- 5. I am a tenant in common in the above-described property. This declaration applies to my ownership interest and is intended to secure the maximum homestead exemption available under Washington law.
- 6. This property serves as my principal residence and is also used in part for family agricultural purposes. The farming activities conducted on the premises are home-based, family-run, and provide our primary source of income and sustenance. These agricultural operations are integral to our household livelihood and are incidental to residential use.
