Beginning at the Northwest corper of the Southeast ¼ of the Northwest ¼ of said Section; thence East along the Northwest interior of said Southeast ¼ of the Northwest ¼, 135 feet; thence South parallel with the West line of said Southeast ¼ of the Northwest ¼, 205 feet; thence West parallel with the North line of said South ½ of the Northwest ¼ to intersect with the East line of that certain easement granted to Rithard Ø.
