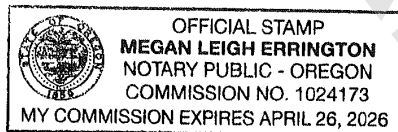

BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

THAT PORTION OF THE ABOVE DESCRIBED REAL PROPERTY LYING SOUTH OF THE FOLLOWING DESCRIBED LINE:
