Seel, without further court intervention and in fulfillment of the terms of the Last Will and Testament of Donna K. Seel, hereby bargains, sells, and conveys to Charles S. Seel, or his successor, as Trustee of the Donna Seel Marital Trust established by the Last Will and Testament of Donna K. Seel dated January 31, 2025, all of the interest of the Estate of Donna K. Seel, and all of his individual interest in the following-described real estate, situated in the County of Skagit, State of Washington:

(0.1600 ac) (LMD1) LOT 19, WEST VIEW, REPLAT OF BLOCK 40, MONTBORNE, SKAGIT COUNTY, WASHINGTON, AS PER PLAT RECORDED IN VOLUME 6 OF PLATS, PAGE 5, RECORDS OF SKAGIT COUNTY, WASHINGTON. TOGETHER WITH THAT PORTION OF THE 100 FOOT WIDE RAILROAD RIGHT-OF-WAY, COMMONLY KNOWN AS THE

NORTHERN PACIFIC RAILWAY (AS ORIGINALLY CONVEYED TO THE SEATTLE LAKE SHORE AND EASTERN RAILWAY) ADJOINING THE PLAT OF WEST VIEW, REPLAT OF BLOCK 40, MONTBORNE, SKAGIT COUNTY, WASHINGTON, AS PER PLAT RECORDED IN VOLUME 6 OF PLATS, PAGE 5, RECORDS OF SKAGIT COUNTY, WASHINGTON, THAT LIES WESTERLY OF THE CENTERLINE OF SAID RIGHT-OF-WAY AND BETWEEN THE NORTHEASTERLY EXTENSIONS OF BOTH THE NORTHWESTERLY AND THE SOUTHEASTERLY LINES OF LOT 19 OF SAID PLAT; EXCEPT THAT PORTION, THEREOF, IF ANY, LYING WITHIN THE COUNTY ROAD RIGHT-OF-WAY; SITUATE IN THE CITY OF MOUNT VERNON, COUNTY OF SKAGIT, STATE OF WASHINGTON.

The Grantors, for said Estate and for its successors in interest, does by these presents expressly limit the covenants of this Deed to those herein expressed, and excludes all covenants arising or to arise by statutory or other implications.

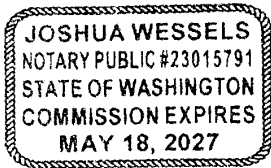
