The Skagit County Board of Health met in regular session on Tuesday, August 19, 2025, with Chair Peter Browning, and Commissioner Lisa Janicki present. Commissioner Ron Wesen's absence was excused.

- b) 10:05 a.m. Public Health Director Remarks

Public Health Director Keith Higman commented on Governor Bob Ferguson's appointment of Dennis Worsham as the state's next Secretary of Health, the North Star meeting on September 9, 2025, taking place at the City of Mount Vernon Library Commons, and Population Health Trust's Powerful Partnership event on October 2, 2025, taking place at McIntyre Hall in Mount Vernon.

c) 10:10 a.m. Population Health Trust Appointments:

Public Health Analyst Kristen Ekstran provided information about new members joining the Population Health Trust Community Health Advisory Board (PHT): Jeremey Haitt with the Skagit Valley Boys and Girls Club, Alex Gee with Skagit County Public Health, and Lindsay Lopes with Behavioral Health, North Sound BH-ASO. She also provided information about the renewal of members, and members that were leaving the PHT Board.

Discussion ensued about the work the PHT Board did and how their work provided guidance to the Board of Health.

A motion was made by Commissioner Janicki to approve the Resolution confirming community members to serve on the Population Health Trust Community Advisory Committee for a three-year term starting on August 19, 2025 and expiring on August 19, 2028. **(Resolution No. R20250189)** Chair Browning seconded the motion. The vote passed unanimously. . Commissioner Ron Wesen's absence was excused.

d) 10:15 a.m. Presentation: Skagit County Public Health Emergency Communications Plan

Community Health Coordinator Karsyn Hansen presented the Skagit County Public Health Emergency Communications Plan (Plan). Ms. Hansen said that the purpose of the Plan was to provide effective internal and external communications guidance in response to an incident or event that threatened the health of residents of Skagit County. She said that effective communication was essential to protect public health during emergencies.

Ms. Hansen mentioned that the Plan was reviewed and updated at least once every other year, and that it was maintained by Skagit County Public Health. This year's update included Centers for Disease Control (CDC) crisis risk communications principles, plain language guidelines, clarification around roles and responsibilities, communications during an emergency, and risk communications activities.

Discussion ensued about communicating public health information throughout the county.
