Chair Wesen convened the Board of Health at and performed the roll call at 11:01 a.m.

Board of Health:

Several members of the Population Health Trust Advisory Committee were present at the virtual meeting.

Assistant Public Health Director Bob Hicks provided a PowerPoint presentation regarding the change the legislature approved to the Revised Code of Washington (RCW) 70.58A.560, which involved the fees that public health agencies charged for the issuance of certifications or informational copies of vital records. He noted that in order to comply with RCW 70.58A.560 Skagit County needed to increase the fee for vital records from \$20 to \$25 per record which would become effective on January 1, 2021.

 Public Hearing to Consider Testimony Regarding the Proposed Amendment to the Existing Public Health Schedule of Charges Regarding Vital Records

Chair Wesen opened the public hearing at 11:06 a.m. Hearing no public testimony forthcoming, Commissioner Janicki made a motion to close the public hearing at 11:07 a.m. Commissioner Dahlstedt seconded the motion. The vote passed unanimously.

Possible Action - Resolution to Adopt a Revised Public Health Schedule of Charges Regarding Vital Records

A motion was made by Commissioner Dahlstedt to approve the Resolution to adopt a revised Public Health Schedule of Charges regarding Vital Records. (**Resolution No. R20200199**) Dr. Aaron Katz, at large member, seconded the motion. The vote passed unanimously.

Public Health Director Jennifer Johnson provided a PowerPoint presentation and expressed concerns that the number of COVID-19 cases in Skagit County were rising. She said that in the first two weeks of November, Skagit County had 360 confirmed cases of COVID-19 which brought the total number of cases to 1,621, 25 people had died and 116 had been hospitalized. Ms. Johnson noted that Skagit County was not meeting three of the key metrics of Governor Inslee's risk assessment dashboard. She reported that the rate per 100,000 of newly diagnosed cases over the last two weeks was 90.6 and the percentage of cases that tested positives was 3.5%. The goal of positive tests on the risk assessment dashboard was less than 2%. Ms. Johnson said that Skagit County was currently in the third wave of the pandemic and is projected to reach 210.5 cases per 100,000 residents.

She addressed hospital capacity and reported that Washington State was experiencing a surge in hospitalizations and stressed the importance of keeping hospital staff healthy so that they could continue to care for patients. Skagit County had 4.2% of COVID-19 patients in the hospital, although that number met the metric of less than 10%, it was a significant increase from two weeks ago. She said that disease investigation was one of Skagit County's top priorities. Due to the sharp rise in new cases in the last week, Skagit County Public Health requested surge assistance

from the Washington State Department of Health through the Health Central Investigation Team. The Health Central Investigation Team began its work on November 11 to conduct contact tracing and investigation calls on behalf of Skagit County. Skagit County Public Health would continue to perform several tasks which include: notifying positive cases tested through the County operated test site; responding to the needs of quarantined individuals; outbreak investigations; testing at long-term care and adult family homes; infection control, supporting schools through case and contact communications, following-up with employers; case contact isolation and sending out quarantine letters; data review; epidemiology reporting; hiring and training additional temporary disease investigators through the new Department of Health CREST interview online portal.

Ms. Johnson said that the COVID-19 test site would be closed on November 16 and 17 so that they could move from Skagit Valley College parking lot to the Skagit County Fairgrounds in Building F. The entrance for the test site is located at the south gate entrance, at 501 Taylor Street in Mount Vernon. She said that the move was necessary due to winter weather. One of the benefits of relocating to the Fairgrounds was that the site was covered and allowed people to remain in their vehicles while they are being tested and it would help to reduce operating costs. The operating hours for the test site are Monday, Wednesday, and Friday from 10:00 a.m. to 4:00 p.m. and Tuesday and Thursdays from 12:00 p.m. to 7:00 p.m. Ms. Johnson expressed sincere appreciation to Skagit Valley College for allowing them to run the test site from their parking lot. She thanked the County Commissioners, Sheriff, Department of Emergency Management, Parks, Recreation, Fair, Public Works, City of Mount Vernon, Northwest Laboratory, Health Officer Dr. Howard Leibrand and Public Health Analyst Julie De Losada for their efforts to support Public Health and the Unified Command Team to make the move to the new test site possible.

Ms. Johnson provided several statistics and said that Unified Command Team had conducted 29,789 tests to date, of which, 18,182 resided in Skagit County. She noted that several testing sites around the County were reporting that they were currently overwhelmed with people wanting to get tested and encouraged people who were asymptotic and without a possible exposure to take a pause from getting testing so the those with symptoms and/or with a possible exposure could get tested.

Ms. Johnson noted that Governor Inslee had recently announced new COVID-19 guidance and restrictions in response to the recent rapid spread of COVID-19. The guidance and restrictions would go into effect on Monday, November 16 at midnight and would be in place until at least December 14, 2020.

There are many changes including:

- No indoor social gatherings are allowed. Outdoor social gatherings can have five or fewer people from outside an immediate household.
- Restaurants and bars are open for outdoor dining and takeout only- no indoor dining is allowed (these restrictions will go into effect on Wednesday, November 18).
- Bowling alleys, movie theaters, museums, zoos and indoor fitness facilities are closed.
- Personal services (such as hair dressers, nail salons, etc.) and retail occupancy, including grocery stores are limited to 25 percent of capacity
- Long-term care facilities can only allow outdoor visitation, except in the cases of end of life care and essential support personnel.
- Religious services are limited to 25% indoor occupancy or 200 people, whichever is fewer. No choir, band or ensemble shall perform during these services. Facial coverings must be worn at all times by congregation members, and there cannot be any congregational singing.
- Wedding receptions are prohibited. Wedding ceremonies will be allowed with no more than 30 people in attendance.
- Youth (school and non-school) and adult sporting activities are limited to outdoor only for intra-team practices, and all athletes must wear masks.
- No real estate open houses.

Governor Inslee is also requiring that those who are able to work from home do so. If a business is not able to operate remotely, only 25% of the building's capacity can work from there at one time. Further, no public services should be provided wherever possible. No changes have been made to the guidance's governing schools or childcare facilities.

She said that a full list was available at the Governor's website at: https://medium.com/wagovernor/inslee-announces-statewide-restrictions-for-four-weeks-cob7da87d34e and encouraged everyone continue to wear a mask and not to panic.

Ms. Johnson announced that there would be a flu vaccine clinic on November 21 and 22 at the Skagit County Fairgrounds.

Public Health Officer Dr. Howard Leibrand discussed the new surge in COVID-19 cases; Governor Inslee's new guidelines which include quarantining yourself for 14 days if you do want to attend small Thanksgiving gathering or quarantining for 7 days and getting a negative test; wearing a mask as much as possible; new testing site; concerns with indoor social gatherings and encouraged people to time visits to retail establishments during non-peak hours if they want to avoid waiting in long lines. He also discussed the numerous cases where people contracted COVID-19 at weddings and funerals. He discussed several new tests and said that dentists would soon be able to test patients in their offices prior to having a dental procedure and that paramedics would be receiving point-of-care antigen testing kits so that they could confirm whether they were ill. He went on to address new medicines and treatments that were being developed which include: remdesivir; Eli Lilly's antibody drug treatment; Regeneron; new vaccines that had met efficacy and safety criteria and distribution of a vaccine. Dr. Leibrand reminded everyone to continue to wear masks and practice physical distancing.

A discussion ensued about how COVID-19 was transmitted in Skagit County; whether there was data that supported that the disease was transmitted at non-household events like restaurants, gyms or grocery stores; improving communication with the public to help educate them about the guidance and restrictions that they were being asked to comply with; various methods to protect the community from COVID-19, government's limited capacity to enforce the guidelines and the Washington State Department of Health's COVID-19 vaccine survey which asked for feedback about how the vaccine should be prioritized across Washington, how people would feel about the vaccine in general and how worried and scarred people were at the drive through test site.
