Your case was transferred to Skagit County Superior Court. Please review these instructions for how to file important documents in your case and how to appear for court.

# Filing Documents in Superior Court

Although this case began in District Court, it has now been transferred to Superior Court for any future hearings. If you file documents for the judge to review before court, you must submit those to the Skagit County Clerk. You can submit them as follows:

## Remote Hearing Instructions

#### Before your hearing, get prepared

- Make sure you have a good Internet connection
- Download Zoom. Practice with the app so you feel comfortable.
- Make sure your screen name is your first and last name.
- Also make sure your profile photo and any backgrounds are appropriate for a court appearance. Virtual or blurred backgrounds are permitted as long as they are not distracting or inappropriate.
- Remember that you are still appearing in court and should act appropriately.
- Charge your computer or mobile device. If you are calling in by phone, make sure you have enough minutes.
- Use earbuds or headphones, if you can. This frees up your hands, and improves sound quality.
- Find a quiet place where no one will interrupt you.
- Have all your papers ready, including a list of what you want to say to the judge


