The Skagit County Coroner's Office offers an unparalleled opportunity to dive into medico-legal death investigations through our *paid and unpaid internship programs*. This immersive experience is designed for students passionate about forensic science, criminal justice, biological sciences, or related fields, offering a unique glimpse into the daily operations of a coroner's office.

Students interested in participating in the internship program <u>must complete</u> the *educational tour* and *observership program* to qualify.

### Educational Tour

This opportunity is approximately 2.5 hours long and is open to high school seniors, college, graduate, and medical students, and community members who are considering a career in forensic science or related field. It includes an overview presentation to introduce learners to the work that the Skagit County Coroner's Office does each day. Participants will receive a full tour of the facility and staff members will be available to answer any questions.

### Observership Program

An observership is an educational experience that allows the participant to shadow a member of the Skagit County Coroner's Office staff for a day up to 5 days and learn more about the field and the inner workings of a coroner's office. This opportunity is open to college, graduate, medical students, and those pursuing a career related to this field. The observer will be under direct supervision by a staff member of Skagit County Coroner's Office and will have the opportunity to respond and observe a death scene investigation or observe an autopsy. Applicants must have completed the educational tour separately to be considered for this program.

★ Due to the privacy and sensitivity of cases, the Skagit County Coroner's Office is very limited as to how many interns may be accepted. It is preferable for individuals to apply only if seriously interested and/or actively pursuing a death investigation career or similar. It is asked that individuals only apply for the internship if able to devote a large amount of time and flexibility to the program.

#### Qualifications:

- Must be 19 years or older
  - High school senior students receiving school credit may be considered for participation.
- Pursuing a career and/or education in criminal justice, forensic science, mortuary science, law enforcement, or medicine.
- Ability to commit to the internship for 3 months with a minimum of 8 hours per week.
- Availability to respond to calls after hours with an investigator (at least 1 day per week) which may include weekends and holidays.
- Must be punctual and respectful of the investigators' multiple duties and busy schedules.
- Must be comfortable interacting with the public both in person and via phone.
- Familiar with basic death investigation principles and/or physiology/anatomy.
- Maintain a professional demeanor and appearance for public interaction.
- Strong interpersonal skills, self-motivation, professional conduct, and sound judgment.

- Every application will be reviewed and considered. Students will receive notification if they have met the minimum requirements and will proceed to the interview process. The student is expected to attend an inperson interview at the Skagit County Coroner's Office.
- Paid Internships are offered only during the summer quarter and restricted to college, graduate, or medical students. Only 1 paid internship is offered per year and the intern must be committed to interning June-September 40 hours per week. Applicants must complete the internship application and additional forms as well as apply for the position when it is posted on-line.

Interns are expected to maintain a log or journal of their experience throughout their internship and will submit it to the Coroner at the conclusion of their internship.

Students fortunate enough to qualify for an internship with the Skagit County Coroner's Office are all expected to meet high standards of personal conduct and professional ethics, as well as maintain attention to punctuality, deadlines, and cooperation with others. ## OBSERVERSHIP ATTIRE, APPEARANCE, AND RESPONSIBILITY POLICY

## Purpose:

To provide standards commensurate with professional attire, appearance, and responsibility for the Skagit County Coroner's Office Observership Program Participants.

## Policy:

An observer functions under the authority of Coroner personnel and is expected to exhibit respectfulness, maturity, and professionalism. As well, an observer is expected to function during the autopsies under the auspices of our forensic pathologist. This office encounters many outside agencies (law enforcement, EMS, fire, public utilities, medical facilities, social services etc.) within the course of investigations, and an observer is expected to be of a maturity such that they conduct themselves commendably with these agencies. Anything other than a professional presentation, in both dress and behavior, is unacceptable and means for dismissal.

## A. Appearance and General Requirements

## Appropriate attire

- All observership participants will wear black cargo style pants and plain black shirt.
- For autopsy, all observership participants must wear scrub pants and shirt.

## Unacceptable Attire includes but is not limited to:

- Jeans, sweatpants, sweatshirts, cutoffs or shorts, sheer clothing, low necklines, stretch pants, spaghetti straps, backless attire, casual sandals, or flip flops. No emblems, slogans, symbols, pins, buttons, insignias connotating illicit substances, alcohol, tobacco, obscene language, sex, violence, or discrimination.
- Footwear
  - Closed-toe shoes must be worn for all scene investigations. No opentoed shoes for females are permitted in the office as well as no bright colored shoes.

## B. Jewelry, Piercings, and Tattoos

- Limited jewelry. No dangling or large hoop earrings as they might create a safety hazard or interfere with the use of personal protective equipment.
- Body piercing must be limited to two per ear.
- No nose, lip, or tongue piercing
- Tattoos that are perceived as offensive and hostile, must be covered or otherwise not visible.

## C. Responsibility

 It is the observer's responsibility to abide by this policy during the observership at the Skagit County Coroner's Office. Non-compliance with the attire and appearance policy may result in termination of the Observership.
