b) ADMINISTRATIVE SERVICES:

Personal Services Agreement with Innovative Environments, LLC to provide policy assistance related to forest
practices issues, including administration of the Forest Advisory Board, and advising Skagit County on statelevel forest lands and natural resources issues. Compensation shall not exceed \$60,000 and is based on an
hourly rate. The Agreement is ratified to commence on January 1, 2020 and continue until December 31,

Amendment No. 1 to Personal Services Agreement No. C20170578 with Volunteers of America Western Washington (VOAWW) to provide services for Skagit County operating as the designated Dispute Resolution Center as outlined in the Revised Code of Washington (RCW 7.75). This Amendment adds Initial Basic Mediation Training and sign-up for the Practicum for Certification to the Scope of Work (Exhibit A) and includes a one-time payment of \$9,600 for these services. The term remains the same and shall continue until December 31, 2020. All other terms and conditions of the original Agreement shall remain in effect.

d) PUBLIC WORKS:

- 5. Amendment No. 1 to Interlocal Cooperative Agreement No. C20190004 with Skagit Conservation District for the design, plans, and specifications for the removal of the Maddox Creek Culvert Fish Passage Barrier Project. This Amendment increases compensation by \$3,200 to fund additional design work. Total compensation shall not exceed \$11,700. All other terms and conditions of the original Agreement shall remain in effect including the termination date of December 31, 2020.
- 6. Agreement for Grant Sub-Award with Puget Sound Restoration Fund (Sub-award Recipient) to provide services to the County for tasks pertaining to Task 3 Pinto Abalone Recovery under the Washington State Department of Ecology Grant SEANWS-2019-SkCoPW-00003 (Skagit County Contract No. C20190432). Compensation to Sub-award Recipient for completed work and services shall not exceed \$21,000. The Agreement is ratified to commence on October 1, 2019, and continue through September 30, 2020.

- 1. Personal Services Agreement with Opportunity Council to utilize Opportunity Council as a subrecipient to administer the Tenant Based Rental Assistance (TBRA) program in Island County to provide tenant based rental assistance to low-income individuals and/or families who are homeless or at risk of becoming homeless. Skagit County will provide the subrecipient Opportunity Council with \$70,157 of HOME funding to implement the Consortium's TBRA program. The Agreement is ratified to commence on January 1, 2020 and continue until December 31, 2021.
- 2. Personal Services Agreement with Opportunity Council to utilize Opportunity Council as a subrecipient to administer the Tenant Based Rental Assistance (TBRA) program in Whatcom County to provide tenant based rental assistance to low-income individuals and/or families who are homeless or at risk of becoming homeless. Skagit County will provide the subrecipient Opportunity Council with \$105,235 of HOME funding to implement the Consortium's TBRA program. The Agreement is ratified to commence on January 1, 2020 and continue until December 31, 2021.
- 3. Personal Services Agreement with Community Action of Skagit County to utilize Community Action of Skagit County as a subrecipient to administer the Tenant Based Rental Assistance (TBRA) program in Skagit County to provide tenant based rental assistance to low-income individuals and/or families who are homeless or at risk of becoming homeless. Skagit County will provide the subrecipient Community Action of Skagit County with \$131,544 of HOME funding to implement the Consortium's TBRA program. The Agreement is ratified to commence on January 1, 2020 and continue until December 31, 2021.

4. Personal Services Agreement with Community Action of Skagit County to provide HOME Tenant Based Rental Assistance (TBRA) for people with behavioral health disorders. Compensation shall not exceed \$30,000 and is based on an administrative rate schedule for the provision of the TBRA program. The Agreement is ratified to commence on January 1, 2020, and continue until December 31, 2020.
