b) EMERGENCY MEDICAL SERVICES:

4. Amendment No. 1 to Personal Services Agreement No. C20180423 with Kirk Hale to perform ombudsman and liaison services between Skagit County and Central Valley Ambulance Authority (CVAA) for the CVAA dissolution. This Amendment terminates the Agreement as of 12:00 p.m. December 20, 2018.

c) PUBLIC HEALTH:

5. Personal Services Agreement with Language Exchange for the provision of interpreter and translation services as requested for the Public Health Department. Compensation shall not exceed \$15,000 and is based on a rate schedule. The Agreement is ratified to commence on January 1, 2019, and shall continue until December 31, 2019.

d) PUBLIC WORKS:

- 6. Resolution calling for bids for the procurement of Maintenance Materials with Annual Purchases Expected to Exceed \$25,000. The call for bids will be for the following materials: liquid asphalt, gravel products, rock products, specialty and mixed asphalt products, concrete products, road salt, culvert lining, and slope stabilization products. The bid opening is scheduled to take place on Monday, January 28, 2019, at 2:45 p.m. or as soon as possible thereafter in the Commissioners Hearing Room.
- 7. Vendor Services Agreement with SSI Shredding Systems, Inc. to provide compactor maintenance, inspection and repair services on the compactor located at the Skagit County Transfer and Recycling Station in Mount Vernon. Total compensation shall not exceed \$30,000 and is based on a rate schedule. The Agreement is ratified to commence on January 3, 2019, and shall continue for two years.
- 8. Amendment No. 1 to Local Agency A&E Professional Services Consultant Agreement No. C20180009 with Natural Systems Design, Inc. for the Concrete-Sauk Valley Road Bank Stabilization and Fish Passage Project, #ES8000-10. This Amendment extends the term of the Agreement by one year due to delays acquiring right-of-entry from adjacent property owners and the need to complete the analysis and design alternatives. Compensation remains the same and shall not exceed \$224,350. The Agreement shall continue through January 8, 2020. All other terms and conditions of the original Agreement shall remain in effect.
- 9. Interlocal Cooperative Agreement with Skagit Conservation District for the design, plans, and specifications for the removal of the Maddox Creek Culvert fish passage barrier project. Skagit County was awarded funding from the Department of Ecology for this project per Contract No. C20180651. Compensation to Skagit Conservation District shall not exceed \$8,500 to carry out the requirements under the grant award. The Agreement shall commence on the date of execution and continue through December 31, 2020.
- 10. Interlocal Cooperative Agreement with Skagit Conservation District for continued coordination, development and the provision of outreach programs in Skagit County for the storm water education requirements of the National Pollutant Discharge Elimination System Phase II permit. Compensation to Skagit Conservation District shall not exceed \$20,746 to carry out the requirements outlined in the Agreement. The Agreement is ratified to commence on January 1, 2019, and shall continue through December 31, 2019.
- 11. Interlocal Cooperative Agreement with Samish Indian Nation for continued water quality monitoring in the Samish basin, on a reimbursable basis, to assist Skagit County in completing specified tasks related to Skagit County's Critical Areas Ordinance and Clean Water Program. Compensation shall not exceed a total of \$24,000. The Agreement is ratified to commence on January 1, 2019, and continue through December 31, 2020.
