# b) CONSERVATION FUTURES:

2. Personal Services Agreement with Kai Ottesen and Jules Riske, dba Belle Bean Services to provide annual monitoring services to Skagit County's Farmland Legacy Program Conservation Easements. Total compensation shall not exceed \$80,000 and is based on an hourly fee. The Agreement shall commence on the date of execution and continue until December 31, 2021.

- 5. Resolution authorizing the conveyance of Skagit County real property located at 1412 Walter Street, Mount Vernon, Parcel No. P54353 to Housing Authority of Skagit County per Interlocal Cooperative Agreement No. C20190468.
- 6. Interlocal Cooperative Agreement with the City of Mount Vernon to facilitate a Senior Services Program, including providing congregate, liquid, and delivered meals to the Mount Vernon community. Compensation to Skagit County shall not exceed \$55,472. The Agreement is ratified to commence on January 1, 2020, and continue through December 31, 2020.

The County shall reimburse WDVA an amount not to exceed \$60,000 which is based on the completion of the services and requirements specified in the Agreement. The Agreement is ratified to commence on January 1, 2020, and continue until December 31, 2020.
