Personal Services Agreement with Jennifer Pitner to provide fundraising services for the Skagit County Meals on Wheels program through consistent and diverse grants, individual donations, corporate sponsorships and event income. Compensation is based on a reimbursement schedule and shall not exceed \$40,000. The Agreement is ratified to commence on January 1, 2024 and continue until June 30, 2024.
- 21. Personal Services Agreement with Welcome Home Skagit to manage and operate a Severe Weather Shelter during extreme cold temperatures as requested by the County. Compensation is based on a reimbursement schedule and shall not exceed \$15,000. The Agreement is ratified to commence on January 18, 2024 and continue until March 31, 2024.
- 22. Subaward Agreement with Tenfold Health to support the build out and implementation of Skagit County's North Star framework and Strategic Pillars. Compensation is based on a rate schedule and shall not exceed \$500,000. The Agreement is ratified to commence on January 1, 2024 and continue until December 31, 2024.
- 23. Personal Services Agreement with Tenfold Health to work with Skagit County and the North Star Initiative to strengthen and expand Behavioral Health Recovery Services in Skagit County. Compensation is based on a rate schedule and shall not exceed \$80,000. The Agreement is ratified to commence on January 1, 2024 and continue until December 31, 2024.
