6. Amendment No. 1 to Interagency Agreement No. C20250331 with Washington State Administrative Office of the Courts (AOC), No. IAA26855, to provide reimbursements to assist with costs related to Therapeutic Court to identify individuals before the court with substance use disorders or other behavioral health needs and engage those individuals with community-based therapeutic interventions. This Amendment updates Attachment A: Use of Funds for FY2026. Compensation to Skagit County remains the same and shall not exceed \$495,098. The term remains the same and shall continue until June 30, 2026. All other terms and conditions of the original Agreement shall remain in effect.
7. Amendment No. 2 to Interagency Agreement No. C20250331 with Washington State Administrative Office of the Courts (AOC), No. IAA26855, to provide reimbursements to assist with costs related to Therapeutic Court to identify individuals before the court with substance use disorders or other behavioral health needs and engage those individuals with community-based therapeutic interventions. This Amendment increases compensation to Skagit County from \$495,098 to \$506,164. The term remains the same and shall continue until June 30, 2026. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.

c) EMERGENCY MANAGEMENT:

8. Personal Services Agreement with Environmental Abatement Services, Inc. to conduct asbestos and lead surveys at County-owned properties commonly identified as parcel numbers P42534 and P42425. The surveys are required to fulfill the obligation for a demolition permit from Northwest Clean Air Agency. Compensation is based on a fee schedule and shall not exceed \$5,000. The Agreement shall commence on the date of execution and continue until May 30, 2026.

d) FACILITIES MANAGEMENT:

9. Amendment No. 1 to Vendor Services Agreement No. C20240220 with Trane U.S. Inc. to repair the Trane HVAC system at the Skagit County Community Justice Center located at 201 Suzanne Lane in Mount Vernon. This Amendment extends the term for one (1) additional year and shall continue until May 13, 2027, and increases compensation from \$30,000 to an amount not to exceed \$40,000. All other terms and conditions of the original Agreement shall remain in effect.
10. Vendor Services Agreement with Guardian Security Inc. to annually test engineered smoke control systems at the Skagit County Community Justice Center located at 201 Suzanne Lane in Mount Vernon, and the Skagit County Courthouse Annex, Juvenile Detention Facility located at 700 South 2<sup>nd</sup> Street in Mount Vernon. Compensation is based on a rate schedule and shall not exceed \$25,000 including applicable sales taxes. The Agreement shall commence on April 1, 2026, and continue for two (2) years with an option to extend for one (1) additional year.
11. Vendor Services Agreement with Mr. Truck Wash, Inc. dba Mr. Hood Clean to supply all labor, materials, equipment, and supervision to semi-annually clean three (3) kitchen hoods at the Skagit County Community Justice Center located at 201 Suzanne Lane in Mount Vernon, and one (1) kitchen hood at the Concrete Community Center located at 45821 Railroad Street in Concrete. Compensation is based on a fee schedule and shall not exceed \$20,000 including applicable sales taxes. The Agreement shall commence on May 15, 2026, and continue for two (2) years with an option to extend for one (1) additional year.

e) INFORMATION SERVICES:

12. Master Services Agreement with FileOnQ for the EvidenceOnQ Property and Evidence Solution software, maintenance, and support, as authorized by Sole Source Resolution No. R20250169. The evidence management software system will allow the Skagit County Sheriff's Office to conduct inventory audits that are

required by the Washington State Auditor’s Office. The annual license fee for year one (1) shall not exceed \$19,000 plus applicable sales tax, and for year two (2) shall not exceed \$18,403 plus applicable sales tax. Upon renewal, the license fee rate shall increase by three (3) percent over the initial license term plus applicable sales tax. The Agreement shall commence on the date of execution and shall continue for an initial term of two (2) years. After the initial term, the Agreement shall renew for an additional three (3)-year term.

f) OFFICE OF JUVENILE COURT:

13. Interlocal Cooperative Agreement with Snohomish County to provide housing for juvenile detainees in the Skagit County Juvenile Detention Facility. Compensation shall not exceed \$250 per day per juvenile. The Agreement shall commence on April 5, 2026, and continue until April 5, 2027.

g) PARKS, RECREATION, AND FAIR:

14. Vendor Services Agreement with United Site Services of Nevada, Inc. for the delivery, rental, pumping, cleaning, and removal of portable chemical toilets, which shall include ADA-accessible units; standard units; event units and deluxe units. These units will be delivered to designated locations in and around Skagit County Parks, and at the Skagit County Fairgrounds. Compensation is based on a fee schedule and shall not exceed \$30,000 including applicable sales taxes. The Agreement shall commence on the date of execution and continue for one (1) year.

h) PROSECUTING ATTORNEY:

15. Grant Agreement No. S26-31115-021 with the Washington State Department of Commerce through the Office of Crime Victims Advocacy Community Services Division for SFY 2026 Victim Witness DV Specific Grant to provide funding that strengthens Victim/Witness Assistance program activities and services for Domestic Violence victims. Compensation to Skagit County shall not exceed \$29,333. The Agreement is ratified to commence on February 1, 2026, and continue until June 30, 2026.

i) PUBLIC HEALTH:

16. Amendment No. 4 to Professional Services Contract No. K7237, Skagit County Contract No. C20230533 with Washington State Health Care Authority to provide Substance Use Disorder short-term housing subsidies for Recovery Support Services using opioid abatement funds, for people with substance use disorders who are homeless or at risk of being homeless. This Amendment increases compensation from \$409,766.33 to an amount not to exceed \$446,432.99. The term remains the same and shall continue until June 30, 2026. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
17. Interlocal Cooperative Agreement No. 26-104-EXE-001 with the City of Anacortes to provide \$250,000 of its opioid settlement funding to support start-up and initial operating costs for the Skagit STAR Center. The Agreement shall commence on the date of execution and continue until June 30, 2028.
18. Resolution authorizing Public Health Director Monica Negrila to electronically sign a Memorandum of Understanding with the Washington State Department of Health for Confidential Information or Limited Dataset(s), (DSA No. 2028-06-01) for Homelessness Experience Death Data.
19. Memorandum of Understanding with the Washington State Department of Health for Confidential Information or Limited Dataset(s) (DSA No. 2028-06-01) for Homelessness Experience Death Data.

j) PUBLIC WORKS:

20. Amendment No. 6 to Grant Agreement No. C20250304 with the Washington State Conservation Commission (2025-2027 Biennium Contract No. K2625) for the continued development and implementation of the Skagit County Voluntary Stewardship Program (VSP) work plan. This Amendment reduces funds in the amount of \$7,600 from Benson Outcome #5 DIP category, and awards funds for a new project called McDougall Outcome #8 in the amount \$7,500. Total compensation shall not exceed \$426,440. The term remains the same and shall continue until June 30, 2027. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
21. Amendment No. 1 to Personal Services Agreement No. C20240436 with KPFF, Inc. to continue advancing the Mill Creek Restoration Project. Funding is provided from the Washington State Recreation and Conservation Office by and through Salmon Recovery Funding Board, Skagit County Agreement No. C20230526 and a Puget Sound Energy (PSE) Service Funding Agreement No. C20240251. This Amendment revises Exhibit “A” to reflect geotechnical and survey work not previously included. Compensation is increased from \$498,258 to an amount not to exceed \$1,109,393.83. The term remains the same and shall continue until December 31, 2026. All other terms and conditions of the original Agreement shall remain in effect.

22. Construction Contract Agreement with Earthwork Solutions, LLC to do all work and furnish all tools, materials, equipment, and transportation required for the construction of the Stevens Creek Fish Passage Improvement Project #ES07000-15. Compensation shall not exceed \$1,032,398.90 and was awarded by Resolution No. R20260047. The Agreement shall commence on the date of execution and shall continue until project completion.
