b) PARKS AND RECREATION:

4. Personal Services Agreement with Pacific Landscape Architecture to provide predesign and conceptual planning services for Young's Park improvements. Compensation is based on a rate schedule and shall not exceed \$25,000. The Agreement shall commence on the date of execution and continue until April 30, 2027.

c) PLANNING AND DEVELOPMENT SERVICES:

5. Personal Services Agreement with T.Y. Lin International to provide Development Plan Review and Site Inspection Services for stormwater permitting in compliance with Skagit County Code and Washington State Department of Ecology Stormwater Manual for Western Washington. Reviews will be through task orders. Compensation is based on a rate schedule and shall not exceed \$50,000. The Agreement shall commence on the date of execution and continue until March 31, 2027.

d) PUBLIC DEFENDER:

6. Personal Services Agreement with Mai Nguyen to provide social work services as outlined in Exhibit "A" and as requested by the Skagit County Public Defender. Compensation is based on an hourly rate schedule and shall not exceed \$72,000. The Agreement shall commence on May 1, 2026, and continue until December 31, 2026.

e) PUBLIC HEALTH:

7. Personal Services Agreement with Achara Consulting, Inc. to present on the topic of behavioral health at the North Star Symposium on May 21, 2026. Compensation shall not exceed \$6,000. The Agreement is ratified to commence on April 15, 2026 and shall continue until July 1, 2026.
8. Personal Services Agreement with Christopher Poulos to present on the topic of behavioral health at the North Star Symposium on May 21, 2026. Compensation shall not exceed \$7,500. The Agreement is ratified to commence on April 15, 2026 and shall continue until July 1, 2026.
9. Amendment No. 2 to Professional Services Contract No. C20240258 with Washington State Health Care Authority (HCA Contract No. K7481) for Access to Baby and Child Dentistry (ABCD) Services to detect and prevent early childhood dental decay by engaging dentists and local public health departments in outreach and case management. This Amendment extends the term of the Agreement by two years to continue until June 30, 2028 and increases compensation from \$107,886 to an amount not to exceed \$184,272. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.

13. Landowner Agreement with Calen and Toni Roberts to remove invasive vegetation and replant native plants at 3098 Butler Creek Road in Sedro-Woolley. This project will benefit water quality. Compensation will be funded by the Washington State Conservation Commission (SCC) 2025-27 Biennium Contract No. K2625 and pursuant to Skagit County Agreement No. C20250304. The Agreement shall commence on the date of execution and continue for ten years.

14. Construction Contract Agreement with Stabbert Marine & Industrial, LLC for the 2026 M/V Guemes Pierside Maintenance Project FEHO26-1. Compensation shall not exceed \$175,014 and was awarded through Resolution No. R20260059. The Agreement shall commence on the date of execution and continue until project completion.
15. Personal Services Agreement with Fred C. Strickland & Associates, LLC to conduct and prepare property evaluations, appraisals, and/or reviews as-needed, through task assignments, for the Farmland Legacy Program or other programs. Compensation is based on an hourly rate schedule and shall not exceed \$20,000. The Agreement is ratified to commence on March 20, 2026 and shall continue until March 31, 2028.
16. Right of Entry Agreement with City of Seattle (Seattle City Light) to allow Skagit County access to property known as Parcel Numbers P43130 and P42598 to complete geotechnical explorations and survey work for the Mill Creek Phase 1 of the South Skagit Highway Floodplain Restoration Project. No compensation is associated with this Agreement. The Agreement is ratified to commence on April 1, 2026 and shall continue until March 31, 2027.
17. Amendment No. 1 to Vendor Services Agreement No. C20240191 with Unitec Corporation to provide scale calibration, maintenance, and repair as it relates to the Skagit County Transfer and Recycling Station and the Sauk Transfer Station. This Amendment increases compensation by \$500 to pay for additional expenses. Total compensation shall not exceed \$39,500. The term remains the same and shall continue until May 7, 2026. All other terms and conditions of the original Agreement shall remain in effect.
18. Amendment No. 1 to Interlocal Cooperative Agreement No. C20250491 with Skagit Conservation District to allow the County to work with the District on a reimbursable basis for assistance to be provided by the District to the County in meeting Voluntary Stewardship Program (VSP) enhancement goals through implementation of site-specific projects. This Amendment adds an additional project (McDougall) and increases compensation by \$7,500 for a new total compensation amount not to exceed \$41,250. The term remains the same and shall continue until June 30, 2027. All other terms and conditions of the original Agreement shall remain in effect.

Amendment No. 1 to Personal Services Agreement No. C20250564 with Community Action of Skagit County to manage and operate a Severe Weather Shelter during extreme cold temperatures at the request of Skagit County Public Health at the Concrete Community Center located at 45821 Railroad Avenue in Concrete. This Amendment redistributes compensation in Exhibit "B". Compensation remains the same and shall not exceed \$64,140.67. The term remains the same and shall continue until April 30, 2026. All other terms and conditions of the original Agreement shall remain in effect.
