# **BUDGET/FINANCE:**

3. Memorandum of Agreement between Skagit County and the Children's Museum of Skagit County for the promotion of programs and special events at the Children's Museum. The agreement shall commence on January 1, 2005, and continue through December 31, 2005. Total value of this agreement for the provision of tourism promotion is \$2,000.

## HUMAN SERVICES:

- 4. Resolution appointing Norman Johnson as a County designated Mental Health Professional for the term effective April 26, 2005. The appointment is at will and subject to review, or exists unless and until decertified or terminated from his employment with Compass Health.
- 5. Amendment No. 3 to Interagency Agreement <u>No. C20040043</u> between Skagit County and the North Sound Mental Health Administration (NSMHA), which reflects the extension to the Center for Medicaid and Medicare Services Transition Plan that allows continued flexible use of Medicaid savings through June 30, 2005. The agreement shall commence on April 18, 2005, and continue until April 18, 2007.
- 14. Local Agency Standard Consultant Agreement with Universal Field Services, Inc. to provide rightof-way services for various Skagit County projects. The agreement shall commence on April 6, 2005, and continue until April 6, 2007. Compensation is not to exceed a total of \$99,000.
