Intergovernmental Agreement with Washington State Military Department (WMD), MIL Contract No. U22-036 to reimburse Skagit County for flooding that occurred in November 2021 that resulted in extensive damage to homes and personal property. WMD will reimburse Skagit County an amount not to exceed \$108,438 which includes \$10,000 for travel, training, and mentorship, for Individual Assistance costs related to Disaster Case Management pursuant to request No. WA-2021111911971. The Agreement shall commence on the date of mutual execution and continue until June 30, 2022.
- 4. Agreement with The Salvation Army to provide Disaster Case Management services for persons displaced from their residences as a result of damages incurred by the continuous series of severe winter storms, high winds, flooding, landslides and mudslides in November and December of 2021. Compensation is based on an Emergency Disaster Services Case Management Budget and shall not exceed \$98,438. The Agreement is ratified to commence on April 1, 2022, and continue until June 30, 2022.
- 5. Spill Prevention, Preparedness, and Response Equipment Grant Agreement No. SPPREG-2123-SgCDEM-00007 with Washington State Department of Ecology (DOE) to provide funding to replace thirty-four (34) gas meters and one (1) calibration station in Skagit County Fire Departments/districts. Compensation to Skagit County shall not exceed \$66,600. The Agreement is ratified to commence on July 1, 2021, and continue until June 30, 2023.
- 6. Grant Agreement No. E22-277 with the Washington State Military Department and the U.S. Department of Homeland Security (DHS) for Fiscal Year (FY) 2020 Emergency Management Performance Grant (20EMPG) program to provide Federal funds to assist governments in preparing for all hazards through sustainment and enhancement of the programs described in the Work Plan. Compensation to Skagit County shall not exceed \$22,000. The Grant Agreement is ratified to commence on January 1, 2022, and continue until September 30, 2022.

c) HUMAN RESOURCES:

7. Memorandum of Understanding (MOU) Amendment No. 2 to Collective Bargaining Agreement No. C20200353 with the Skagit County Deputy Sheriff's Guild. This Amendment updates the wage terms due to the impact of bargaining regarding the implementation of body worn cameras. The term remains the same and shall continue until December 31, 2022. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.

d) PARKS, RECREATION AND FAIR:

8. Personal Services Agreement with Cowling & Company LLC dba Widener & Associates to assist with the completion of the required procedures and documentation for Federal Emergency Management Agency (FEMA) Public Assistance Washington Flooding and Mudslides (DR-4635) Projects.
