- 22. Amendment No. 1 to Vendor Services Agreement No. C20190178 with Skagit Soils, Inc. to process yard waste including grass, leaves, brush, and organic trimmings. This Amendment extends the term by one year, ending June 12, 2022. Compensation remains the same and shall not exceed a total of \$24,000 and is based on a fee schedule. All other terms and conditions of the original Agreement shall remain in effect.
- 23. Amendment No. 1 to the Rural Arterial Program Agreement, Skagit County Contract No. C20190201, with the County Road Administration Board (CRAB), Project No. 2919-01, for the Francis Road Reconstruction, Section 3 Project, Road No. 79000. This Amendment increases compensation to Skagit County from \$287,221 to \$1,487,221. The term remains the same and shall continue until April 26, 2027. All other terms and conditions of the original Agreement shall remain in effect.
