b) ADMINISTRATIVE SERVICES:

- 3. Interagency Agreement with Washington State Department of Commerce through the Coronavirus Relief Fund for Local Governments, Contract No. 20-6541C-029, for costs incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19) during the period of March 1, 2020 thru October 31, 2020. Compensation to Skagit County shall not exceed \$7,106,000.
- 4. Resolution approving the use of CARES Act funds in the amount of \$1,000,000 to establish a small business grant program.

c) EMERGENCY MANAGEMENT:

- 5. Amendment No. 1 to Grant Agreement No. E19-089-Skagit, Skagit County Contract No. C20190098, between Skagit County, the Washington State Military Department and the U.S. Department of Homeland Security for emergency management performance and prevention activities in the prevention, protection, mitigation, response, and recovery regarding catastrophic events, threats, hazards and security. This Amendment changes the contract expiration date from October 31, 2020 to December 31, 2020, changes the Timeline Final Reimbursement Request and Closeout Report due to no later than January 15, 2021, and updates the Key Personnel. Compensation remains the same and shall not exceed \$56,720. All other terms and conditions of the original Agreement shall remain in effect.
- 6. Public Assistance Grant Agreement No. D20-445, with the Washington State Military Department and the Federal Emergency Management Agency (FEMA) for the emergency protective measures taken in response to the COVID-19 pandemic outbreak as approved by FEMA. The Grant Agreement period commenced on January 20, 2020, and shall be terminated on March 22, 2024.

d) FACILITIES:

- 7. Vendor Services Agreement with Great Floors to remove and replace carpeting in Hearing Rooms A, B, & C of the Administration Building located at 700 South 2nd Street in Mount Vernon. Compensation shall not exceed \$22,640.56 and is based on a rate sheet. The Agreement is ratified to commence on June 1, 2020, and continue until July 31, 2020.
- 8. Vendor Services Agreement with General Storefronts, Inc. to install a storefront door at Skagit County Superior Court located at 205 West Kincaid Street in Mount Vernon. Compensation shall not exceed \$20,951.93. The Agreement shall commence on the date of execution and continue for seven (7) months.
- 9. Personal Services Agreement with Carletti Architects, P.S. for roof replacement on the Transfer Station's Vactor Waste Building located at 14104 Ovenell Road in Mount Vernon. Compensation shall not exceed \$24,250. The Agreement shall commence on the date of execution and continue until December 31, 2020.
- 10. Vendor Services Agreement with Mr. Hood Clean to provide kitchen hood cleaning services at Skagit County Community Justice Center located at 201 Suzanne Lane in Mount Vernon. Compensation shall not exceed \$4,402.35 and is based on a rate sheet. The Agreement shall commence on the date of execution and continue for three (3) years.
- 11. Personal Services Agreement with Underwood and Associates, LLC for architectural services on the design and cost estimate of adding a morgue to the Coroner's Office located at 1700 Continental Place in Mount Vernon. Compensation shall not exceed \$40,000 plus applicable taxes. The Agreement shall commence on the date of execution and continue until September 30, 2021.

e) HUMAN RESOURCES:

12. Amendment No. 1 to Collective Bargaining Agreement No. C20190166 between Skagit County and Inlandboatmen's Union of the Pacific. This Amendment extends the term of the Agreement to December 31, 2021.

f) PARKS, RECREATION AND FAIR:

13. Resolution to call for a public hearing to consider testimony regarding the revision of the current fee schedule for Howard Miller Steelhead Park, Grandy Lake Park, and Sauk Park campgrounds. The public hearing is

g) PLANNING AND DEVELOPMENT SERVICES:

14. Grant Deed of Conservation Easement Natural Resource Land Easement (NRLE) for Short Plat (CaRD Land Division) #PL19-0292 submitted by Haller Farms Edison, LLC, on Parcel numbers P107509, P48537, P33786, P33787, P33788 and P134521. The proposed land division, completed in compliance with Skagit County Code 14.18.300, will create three (3) 1 acre residential lots and one (1) 117.25 acre lot which will be encumbered by this easement.

h) PUBLIC HEALTH:

- 15. Amendment No. 1 to Personal Services Agreement No. C20190430 with Washington Initiative for Supported Employment (W.I.S.E.) to provide technical assistance services to individuals with disabilities and their families, employment providers and Skagit County's Developmental Disabilities Program. This Amendment increases compensation from \$15,000 to an amount not to exceed \$25,000 and is funded by Developmental Disabilities Funding. The term remains the same and shall continue until June 30, 2020. All other terms and conditions of the original Agreement shall remain in effect.
- 16. Personal Services Agreement with Maureen Pettitt to assist Skagit County Public Health with on-going data collection and analysis regarding COVID-19 to begin to plan for emerging health needs when epidemiology capacity both locally and at a state level is overextended due to the pandemic. Compensation is based on a rate schedule and shall not exceed \$30,000. The Agreement shall commence on the date of execution and continue until May 31, 2021.
- 17. Personal Services Agreement with Dependable Cleaning, LLC to provide cleaning services at the Burlington Inn quarantine and isolation facility for individuals who have been exposed to or tested positive for COVID-19. Compensation shall not exceed \$10,000, and is based on an hourly rate schedule. The Agreement is ratified to commence on May 20, 2020 and continue until June 30, 2020.

i) PUBLIC WORKS:

- 18. Interlocal Cooperative Agreement with Washington State Department of Ecology to facilitate Skagit County's work with the Padilla Bay National Estuarine Research Reserve (NERR) to accomplish work pursuant to Washington State Department of Ecology's Grant Agreement No. SEANWS-2019-SkCoPW-0003, Skagit County Contract No. C20190432, as amended by Amendment No. A20200039, for Task 5 Salish Sea Stewards and Task 6 Kids on the Beach. Total compensation shall not exceed \$62,400. The Agreement is ratified to commence on October 1, 2019 and continue until October 10, 2021.
- 19. Amendment No. 2 to Vendor Services Agreement No. C20180288 with VECA Electric & Technologies, LLC for electrical maintenance and repair services at Guemes Island Ferry Facilities, Solid Waste Facilities, and Operations Facilities. This Amendment extends the term of the Agreement an additional two (2) years and shall expire on June 16, 2022, increases compensation by \$75,000 for a new total compensation amount not to exceed \$175,000, and updates "Exhibit A" of the Agreement "General Nature of Work". All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.

j) SHERIFF:

20. Organized Crime Drug Enforcement Task Forces (OCDETF) Investigation/Strategic Initiative Number PA-WAW-343 for fiscal year 2020, for the purpose of receiving reimbursement for costs incurred by the Skagit County Sheriff's Office in providing resources to joint operations/task forces. OCDETF shall reimburse Skagit County in an amount not to exceed \$15,000. The Agreement is ratified to commence on May 1, 2020 and continue until September 30, 2020.
