The Agreement commenced on June 16, 2025 pursuant to Resolution No. R20250137 and ends on May 31, 2026.

Amendment No. 1 to AIA Standard Form Agreement No. C20250059 with TRICO Companies to provide all labor, materials, and supervision services for tenant improvements on the 3rd floor of the Administration Building located at 700 South 2nd Street in Mount Vernon. This Amendment adds to the Scope of Work to reflect floorplan changes, ducting changes, and additional abatement. Compensation is increased from \$2,119,000 to an amount not to exceed \$2,332,248 plus applicable tax. The term remains the same and shall continue until December 31, 2025. All other terms and conditions of the original Agreement shall remain in effect
- 6. Vendor Services Agreement with Highline Construction, Inc. to provide all labor, materials, and equipment for a tenant improvement project on the 1st floor of the Skagit County Annex Building located at 605 South 3rd Street in Mount Vernon. Compensation is based on a rate schedule and shall not exceed \$194,750.91. The Agreement shall commence on the date of execution but no earlier than September 1, 2025 and continue until December 31, 2025.

d) OFFICE OF JUVENILE COURT:

7. Interlocal Cooperative Agreement with Sedro-Woolley School District to fund a BECCA Case Manager Position to help file truancy petitions, provide truancy intervention, and case management. Compensation to Skagit County shall not exceed \$7,682. The Agreement shall commence on September 1, 2025 and shall continue through August 31, 2026.

Personal Services Agreement with New Earth Recovery to operate three (3) Recovery Residences that will house a monthly average of sixteen (16) people seeking to maintain recovery from substance use disorders. Compensation is based on a rate schedule and shall not exceed \$115,002. The Agreement is ratified to commence on July 1, 2025 and continue until December 31, 2025.
- 12. Vendor Services Agreement with Correctional Healthcare Partners to provide health care services on behalf of Skagit County for Inmates physically in the custody and housed in the Skagit County Community Justice Center, consistent with the National Commission on Correctional Health Care standards. Compensation is based on a fee schedule and shall not exceed \$3,552,437.21 for the first year. The Agreement shall commence

- on September 1, 2025 and continue for five (5) years through September 30, 2030, and may be renewed by mutual agreement of the parties for an additional two (2) year term beginning October 1, 2030, up to two (2) additional years.
- 13. Resolution authorizing Chair Lisa Janicki to electronically sign the submission of Amendment No. 5 to Consolidated Contract No. C20240672 with Washington State Department of Health (DOH Contract No. CLH32065) to add and amend Statements of Work to programs outlined in Exhibit A and increase funding.

The term remains the same and shall continue until December 31, 2027.

County Program Agreement No. 2563-63160 with the State of Washington Department of Social and Health Services (DSHS) Division of Developmental Disabilities to provide employment and services to individuals with developmental disabilities. Compensation to Skagit County shall not exceed \$3,518,858. The Agreement is ratified to commence on July 1, 2025 and continue until June 30, 2027.

g) PUBLIC WORKS:

- 16. Supplemental Agreement No. 2 to Local Agency A&E Professional Services Negotiated Hourly Rate Consultant Agreement No. C20230240 with Transpo Group USA Incorporated for professional engineering, environmental, and right of way services for the Cook Road/I-5 Interchange Vicinity Improvements Project #ES63000-11. This Amendment provides for the addition of a DBE sub-consultant to meet state requirements. Compensation is increased from \$1,052,651.90 to \$1,120,856.60. The term is extended from December 31, 2025 to December 31, 2027. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
- 17. Amendment No. 1 to Vendor Services Agreement No. C20230238 with Industrial Mowing and Spraying to provide mowing and/or brush cutting services within County owned Right-of-Ways. This Amendment extends the term of the Agreement to continue until June 5, 2026. Compensation remains the same and shall not exceed \$30,000. All other terms and conditions of the original Agreement shall remain in effect.
- 18. Interagency Agreement with the State of Washington Department of Transportation (WSDOT), Local Programs, Agreement No. GCC-1233, for grant reimbursement through the Transportation Budget 2025-2027 ESSB 5161, Section 224 for youth passengers on the M/V Guemes Ferry. Compensation from WSDOT shall not exceed \$68,500. The Agreement is ratified to commence on July 1, 2025 and shall continue until June 30, 2027.
- 19. Interagency Agreement GCC 1147 with Washington State Department of Transportation, Local Programs (WSDOT). The Agreement will replace the current Interagency Agreement No. GCB 3515, Skagit County Contract C20210293; which terminated on June 30, 2025. Pursuant to RCW 47.56.725, this Agreement allows Skagit County to receive a subsidy of up to 50% of the previous year's annual operating deficit incurred in the operation and maintenance of the County ferry system. The Agreement is ratified to commence on July 1, 2025, and continue until June 30, 2027.
- 20. Vendor Services Agreement with Clean Harbors Environmental Services, INC. for the Cleaning of One (1) Oil Tank. Compensation shall not exceed \$78,798.84 and was awarded by Resolution No. R20250125. The Agreement shall commence on the date of execution and continue for one (1) year.
- 21. Amendment No. 10 to Local Agency A & E Professional Services Cost Plus Fixed Fee Consultant Agreement No. C20170376, Project No. #ESMVGUE-1 with Glosten to provide design services for the replacement vessel for the Anacortes/Guemes Island route and support Skagit County through vessel procurement and construction. This Amendment extends the completion date from July 31, 2025 to July 31, 2026. Compensation remains the same and shall not exceed \$2,952,572.74.
