Interlocal Cooperative Agreement with the City of Sedro-Woolley to award \$500,000 of Economic Development/Public Facilities Project grant funds to support the SR West Lane Widening & Safety Improvements. The Agreement shall commence on the date of execution, pursuant to Resolution No. R20180116, and shall expire on October 31, 2019.

## c) FACILITIES MANAGEMENT:

- 5. Vendor Services Agreement with Combined Construction to provide sidewalk expansion joint sealing in the proximity of the Administration Building located at 700 South 2<sup>nd</sup> Street, Mount Vernon. Total compensation shall not exceed \$14,900. The Agreement shall commence on the date of execution and continue for six months.
- 6. Personal Services Agreement with Semrau Engineering & Surveying, PLLC to provide a Land Title Survey on the proposed North Sound Behavioral Health Organization Stabilization Campus property including Skagit County Assessor Parcel numbers P104178, P76502, and P76503. Compensation shall not exceed \$25,000 and is based on a fee schedule. The Agreement is ratified to commence on June 1, 2018, and shall continue until December 31, 2019.
- 7. Personal Services Agreement with Howard Consulting, LLC to provide planning and development services for the Skagit County Evaluation and Treatment Center and facilities at the Stabilization Campus. Compensation shall not exceed \$229,100 and is based on a fee schedule. The Agreement is ratified to commence on June 1, 2018, and continue until December 30, 2021.

### d) INFORMATION SERVICES:

- 8. Purchase Reimbursement Agreement PRA19002 with the Washington State Administrative Office of the Courts for the reimbursement of 6 printers, 2 desktop computers, 2 monitors and 6 laptops. The Agreement shall commence on the date of execution and continue through February 28, 2019.
- 9. Amendment No. 4 to Professional Services Agreement No. C20160087 with Cayenta, a division of N. Harris Computer Corporation to develop database views, data integration and modifications to the Employee Self Service system. This Amendment outlines the services, terms, conditions, and fees that will be associated with upgrading to Cayenta Version 7.9 from 7.6.1. Skagit County shall compensate Cayenta for the Support and Maintenance Fee for licensed modules and for value added services requested by Skagit County. Compensation is increased from \$72,060 to not more than \$180,000. All other terms and conditions of the original Agreement and subsequent Amendments shall remain in effect. The term of the Agreement is extended by 8 months and shall continue until August 31, 2019.

# e) OFFICE OF JUVENILE COURT:

- 10. Interlocal Cooperative Agreement with the Concrete School District to jointly fund the BECCA Case Manager position to serve the School Districts and the Skagit County Office of Juvenile Court in implementing the truancy portion of the BECCA Bill as outlined by RCW and WAC. The Agreement shall commence on September 1, 2018, and continue through August 31, 2019. Compensation to Skagit County shall not exceed \$1,157.
- 11. Memorandum of Understanding with the Concrete School District to continue to collaborate to reduce chronic absenteeism and involvement of truant students in court through the development and implementation of culturally appropriate practices and evidence based services that include but are not limited to Community Truancy Boards (CTB) and stay petitions. The Agreement shall commence on September 1, 2018 and shall remain in effect until terminated. There is no monetary consideration associated with this Memorandum.

## h) PUBLIC DEFENDER:

Personal Services Agreement with Shane Harrington to provide investigation services as requested by the Skagit County Public Defender including, but not limited to, witness interviews, preparation of witness interview reports or transcripts, locating witnesses, service of subpoenas, preparation of diagrams, photographing items of evidentiary value, obtaining records and court testimony. Contractor will provide investigation services as requested for adult and juvenile cases. Compensation shall not exceed \$55,417 per year and is based on a fee schedule. The Agreement is ratified to commence on July 16, 2018, and continue until December 31, 2018.
- 17. Personal Services Agreement with Dennis Scott to provide legal defense services to indigent clients charged with offenses in Skagit County Superior Court. Compensation shall not exceed \$45,000 and is based on a rate schedule. The Agreement is ratified to commence on July 16, 2018, and shall continue until December 14, 2018.

### i) PUBLIC WORKS:

- 18. Resolution for a Request for Qualifications for Professional Engineering Services for the Colony Mountain Drive Culvert Replacement Project, #ES24100-2. Submittals are due August 2, 2018.
- 19. Personal Services Agreement with Phillips Environmental Services to provide an inspection and report of a single-family residence located at 31268 West Main Street in Lyman before the County can apply for a demolition permit. Compensation shall not exceed \$1,500. The Agreement shall commence on the date of execution and continue until December 31, 2018.
- 20. Funding Board Project Grant Agreement with the Washington State Salmon Recovery Funding Board and the Recreation and Conservation Office for the Carey Slough Fish Passage Final Design Project.
