This Amendment decreases compensation to Skagit County by \$4,000 for a new total compensation amount not to exceed \$76,000, which is funded by the State Mental Health Promotion Program (MHPP) and the Dedicated Marijuana Account (DMA). This Amendment is ratified to commence on March 15, 2021, and expired on June 30, 2021. All other terms and conditions of the original Agreement shall remain in effect.
- 32. Compensation to Skagit County shall not exceed \$88,900. The Agreement is ratified to commence on July 1, 2021, and continue until June 30, 2023.
- 41. Resolution awarding the bid and appropriating funds for the 2021 HMA Overlay Project #ESHMA21-1 to Lakeside Industries, Inc. in the amount of \$648,350.
- 42. Interagency Agreement with Washington State Department of Agriculture, Contract No. K3528 and Skagit County Noxious Weed Control Board to provide funding for a project to survey for and eradicate invasive Spartina species within Skagit County.
